# A BILL FOR AN ACT

RELATING TO PRIVATE DETECTIVES AND GUARDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Police officers are a special class of law
- 2 enforcement. They receive rigorous training, are subject to
- 3 direct oversight by the State, and wield broad powers to ensure
- 4 the security and safety of the State and its people, including
- 5 the powers to detain and search individuals.
- 6 The roles of some private security guards have expanded.
- 7 Although private security guards make a valuable contribution to
- 8 the security of Hawaii, they are not police officers. It is
- 9 therefore important that an individual know whether the
- 10 individual is dealing with a private security guard or with a
- 11 police officer. Private detectives and guards are not permitted
- 12 to imply any association with a government agency.
- Accordingly, the purpose of this Act is to clarify that
- 14 private detectives and quards are prohibited from self-
- 15 identifying as a law enforcement officer, a police officer, or
- 16 police.

1	SECTION 2. Section 463-11, Hawaii Revised Statutes, is	
2	amended to read as follows:	
3.	"§46	3-11 Association with government not to be implied.
4	[ <del>No</del> ] <u>(a)</u>	Except for a licensee or an employee of a licensee
5	commissioned by the director of transportation under section	
6	261-17 or	section 266-24, no licensee or employee of a licensee
7	shall [ <del>use</del> ]:	
8	(1)	<u>Use</u> any designation or trade name which implies any
9		association with any municipal, county, state, or
10		territorial government or the federal government, or
11		any agency thereof; [nor shall a licensee or employee
12		of any licensee wear]
13	(2)	Wear or use any badge [or], uniform, equipment,
14		vehicle, or other accoutrement capable of being
15		associated with the badge [ex], uniform, equipment,
16		vehicle, or other accoutrement of any law enforcement
17		officer who is employed by a government law
18		enforcement organization[-];
19	(3)	Wear or use any badge, uniform, equipment, vehicle, or
20		other accoutrement that includes the words "police" or
21		"law enforcement"; or

1 (4) Use the terms "law enforcement officer", "police", or

2 "police officer" to self-identify as such.

3 (b) For purposes of this section, "law enforcement

4 officer" has the same meaning as in section 710-1000."

5 SECTION 3. Statutory material to be repealed is bracketed

6 and stricken. New statutory material is underscored.

7 SECTION 4. This Act shall take effect on July 1, 3000.

### Report Title:

Private Detectives; Private Guards; Law Enforcement Officers

#### Description:

Prohibits private detectives and guards from self-identifying as law enforcement officers, police, or police officers and from wearing or using any badge, uniform, equipment, vehicle, or other accoutrement capable of being associated with that of a law enforcement officer employed by a government law enforcement organization.
