# A BILL FOR AN ACT

RELATING TO DENTAL ASSISTANTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that proper certification 2 of dental assistants employed in the State is necessary to ensure the health, safety, and well-being of the State's 3 Currently, Hawaii is one of only a handful of states 4 citizens. 5 that does not require certification of dental assistants. This 6 lack of certification exposes the State's citizens to 7 unnecessary risks whereas proper certification from a respected 8 national board will help ensure that the State's citizens are 9 receiving the best available care.

10 The legislature also finds that the Dental Assisting
11 National Board, Inc., is a national certification board for
12 dental assistants that currently certifies more than thirty13 seven thousand dental assistants nationwide. Moreover, the
14 Dental Assisting National Board's Certified Dental Assistant
15 certification program is accredited by the National Commission
16 for Certifying Agencies.

1	Accordingly, the purpose of this Act is to establish	
2	requireme	nts for dental assistants in Hawaii, including:
3	(1)	Establishing minimum requirements for all individuals
4		hired as dental assistants in Hawaii on or after
5		July 1, 2018;
6	(2)	Requiring dental assistants employed on or after
7		July 1, 2018, to successfully complete the Dental
8		Assisting National Board, Inc.'s National Entry Level
9		Dental Assistant certification within three years of
10		first being hired as a dental assistant;
11	(3)	Requiring dental assistants with four or more years'
12		experience to apply or register for the Dental
13		Assisting National Board, Inc.'s Certified Dental
14		Assistant certification; and
15	(4)	Exempting dental assistants with more than ten years'
16		experience from having to obtain a Certified Dental
17		Assistant certification, but requiring these dental
18		assistants to hold a cardiopulmonary resuscitation
19	30	certification and pass the Dental Assisting National
20		Board, Inc.'s Infection Control examination within two
21		years of the approval date of this Act.

19		Assisting National Board, Inc.'s National Entry Level

1	(b) An individual employed as a dental assistant on or
2	after July 1, 2018, shall provide proof to the board that the
3	dental assistant has successfully completed the Dental Assisting
4	National Board, Inc.'s National Entry Level Dental Assistant

7	(c) An individual employed as a dental assistant for four
8	or more years shall provide proof to the board that the dental
9	assistant has applied or registered for the Dental Assisting

12	or more years shall not be subject to the requirements of
13	subsection (c) but shall within two years of the approval date
14	of this Act:
15	(1) Hold a cardiopulmonary resuscitation certification;

18	passed the Dental Assisting National Board, Inc.'s
19	Infection Control examination.
20	(e) The board shall be responsible for ensuring compliance
21	with the requirements of this section and shall assist licensed

3	(f) Licensed and registered dentists who employ dental
4	assistants shall report the names and certifications of their
5	dental assistants to the board."
6	SECTION 3. New statutory material is underscored.
7	SECTION 4. This Act shall take effect on July 1, 2018.

**Report Title:** Dental Assistants; Certification; Minimum Requirements; Dental Assisting National Board, Inc.

#### Description:

Establishes minimum requirements for all dental assistants hired on or after 7/1/2018. Requires dental assistants employed on or after 7/1/2018 to successfully complete the Dental Assisting National Board, Inc.'s (DANB) National Entry Level Dental Assistant certification within three years of first being hired. Requires dental assistants with four or more years' experience to apply or register for the DANB's Certified Dental Assistant certification. Exempts dental assistants with more than ten years' experience from having to obtain a Certified Dental Assistant certification, but requires these dental assistants to hold a cardiopulmonary resuscitation certification and pass the DANB's Infection Control examination within two years.
