A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE WEIGHT TAX.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii Revised
- 2 Statutes imposes a state motor vehicle weight tax for various
- 3 types of vehicles and authorizes the counties to impose their
- 4 own motor vehicle weight tax.
- 5 The legislature finds that residents with a disability who
- 6 purchase or retrofit a noncommercial motor vehicle with a lift
- 7 or ramp designed to provide ingress and egress in the vehicle by
- 8 the person with disability pay more in state and county motor
- 9 vehicle weight taxes in comparison to residents with non-
- 10 modified vehicles. The extra weight of the vehicle is due to
- 11 the lifts and ramps, any required motors, and additional
- 12 reinforcement of the vehicle chassis.
- 13 The purpose of this Act is to exempt the weight of any
- 14 lifts or ramps installed to assist a person with a disability on
- 15 a noncommercial motor vehicle for purposes of computing annual
- 16 state and county motor vehicle weight taxes.

- 1 SECTION 2. Section 249-1, Hawaii Revised Statutes, is
- 2 amended as follows:
- 3 1. By adding a new definition to be appropriately inserted
- 4 and to read:
- 5 ""Noncommercial motor vehicle" means a motor vehicle or
- 6 combination of motor vehicles not defined by the term
- 7 "commercial motor vehicle" under section 286-2."
- 8 2. By amending the definition of "net weight" to read:
- 9 ""Net weight" of a vehicle means the actual weight of the
- 10 vehicle, as determined on a standard scale, including all
- 11 equipment and accessories ordinarily attached to and used on the
- 12 vehicle and, in the case of a motor vehicle, the maximum fuel,
- 13 oil, and water possible of being carried for its operation;
- 14 provided that "net weight" of a new standard equipped vehicle,
- 15 other than a motor vehicle, means the shipping weight thereof as
- 16 established by its manufacturer, and "net weight" of a new
- 17 standard equipped passenger vehicle means the shipping weight
- 18 thereof as established by its manufacturer, plus one hundred
- 19 pounds, and "net weight" of a new standard equipped motorcycle,
- 20 motor scooter, or moped, means the shipping weight thereof as
- 21 established by its manufacturer, plus thirty pounds, and "net

1 weight" of a new standard equipped truck means the shipping 2 weight thereof as established by its manufacturer, plus two 3 hundred pounds. On initial registration of a standard equipped 4 vehicle, other than a motor vehicle, for which the director of 5 finance has the manufacturer's established weight, the director 6 of finance, in lieu of requiring the vehicle to be weighed and 7 in order to determine the "net weight" thereof, may use such 8 established weight and may require the owner to furnish 9 verification of the factory serial number of the vehicle. 10 initial registration of standard equipped passenger vehicles, 11 motorcycles, motor scooters, mopeds, and trucks for which the 12 director of finance has the manufacturer's established weights, 13 the director of finance, in lieu of requiring such motor 14 vehicles to be weighed and in order to determine the "net 15 weight" thereof, may use such established weights, adding one **16** hundred pounds in the case of standard equipped passenger **17** vehicles, thirty pounds in the case of standard equipped 18 motorcycles, motor scooters, and mopeds, and two hundred pounds 19 in the case of standard equipped trucks, and may require the 20 owners to furnish verification of factory serial and engine 21 numbers of such motor vehicles. As to a vehicle for which the

- 1 manufacturer's weight is not available or whose make and model
- 2 cannot be determined with reasonable certainty or which has been
- 3 so altered as to increase or diminish the weight thereof, "net
- 4 weight" means the actual weight of such vehicle, as determined
- 5 on a standard scale, including all equipment and accessories
- 6 ordinarily attached to and used on the vehicle and, in the case
- 7 of a motor vehicle, the maximum fuel, oil, and water possible of
- 8 being carried for its operation. For all noncommercial motor
- 9 vehicles, the weight of any vehicle modifications made to assist
- 10 a person with a disability to enter or exit the vehicle
- 11 including but not limited to lifts, ramps, motors to power lifts
- 12 or ramps, and chassis reinforcements, shall be excluded from the
- 13 determination of the vehicle's net weight. In all cases
- 14 information shall be presented to and in the manner prescribed
- 15 by the director of finance."
- 16 SECTION 3. New statutory material is underscored.
- 17 SECTION 4. This Act shall take effect on July 1, 2050.

Report Title:

Motor Vehicle Weight Tax; Exemption for Lifts and Ramps

Description:

Excludes the weight of lifts and ramps, motors to operate them, and vehicle chassis reinforcements added to assist a person with a disability, from the determination of net weight of noncommercial motor vehicles for purposes of levying the state and county motor vehicle weight tax. Defines noncommercial motor vehicle. (HB2232 HD1)
