# A BILL FOR AN ACT

RELATING TO COMMERCIAL FISHING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 189-2, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§189-2 Commercial marine license. (a) The department of
- 4 land and natural resources shall issue commercial marine
- 5 licenses for the taking of marine life for commercial purposes.
- 6 The department may establish different subtypes of commercial
- 7 marine licenses, including but not limited to fishery and gear
- 8 specific commercial licenses, commercial fishing vessel
- 9 licenses, and professional or part-time commercial fishing
- 10 licenses, and specify the requirements and qualifications for
- 11 the issuance of these subtype licenses.
- 12 (b) No person shall take marine life for commercial
- 13 purposes whether the marine life is caught or taken within or
- 14 outside of the State, without first obtaining a commercial
- 15 marine license or subtype license, if applicable, as provided in
- 16 this section.

1 [<del>(b)</del>] (c) Additionally, any person providing vessel 2 charter services in the State for the taking of marine life in 3 or outside of the State shall obtain a commercial marine 4 license [-] or subtype license, if applicable. 5  $\left[\frac{\langle c \rangle}{c}\right]$  (d) The department may adopt rules pursuant to 6 chapter 91 necessary for the purpose of this section and to set 7 fees for commercial marine licensing. 8 [<del>(d)</del>] (e) The fees for commercial marine licenses and 9 duplicate commercial marine licenses shall be established by the **10** department by rules adopted in accordance with chapter 91. 11 [<del>(e)</del>] (f) The department shall suspend, shall refuse to **12** renew, reinstate, or restore, or shall deny any license issued **13** under this section if the department has received certification 14 from the child support enforcement agency pursuant to section **15** 576D-13 that the licensee or applicant is not in compliance with 16 an order of support or has failed to comply with a subpoena or 17 warrant relating to a paternity or child support proceeding. 18 The department shall issue, renew, reinstate, or restore such a 19 license only upon receipt of authorization from the child **20** support enforcement agency, the office of child support 21 hearings, or the family court.

- 1 [(f)] (g) The department shall not renew or reinstate, or
- 2 shall deny or suspend any license or application, if the
- 3 department has received certification from an administering
- 4 entity pursuant to chapter 436C that the licensee or applicant
- 5 is in default or breach of any obligation under any student
- 6 loan, student loan repayment contract, or scholarship contract
- 7 that financed the licensee's or applicant's education, or has
- 8 failed to comply with a repayment plan.
- 9 The department in receipt of a certification pursuant to
- 10 chapter 436C shall, as applicable, and without further review or
- 11 hearing:
- 12 (1) Suspend the license;
- 13 (2) Deny the application or request for renewal of the
- 14 license; or
- 15 (3) Deny the request for reinstatement of the license,
- 16 and unless otherwise provided by law, shall renew, reinstate, or
- 17 grant the license only upon receipt of an authorization from the
- 18 administering entity."
