A BILL FOR AN ACT

RELATING TO CONSUMER PROTECTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that deferred deposit
2	agreements, commonly referred to as payday loans, are small,
3	short term, unsecured loans that borrowers commit to repay from
4	their next paycheck or a regular income payment. According to a
5	study by the Pew Charitable Trusts, the majority of borrowers
6	use deferred deposit agreements for recurring expenses, rather
7	than unexpected expenses or emergencies, because they live
8	paycheck to paycheck. Research has also shown that the
9	conventional payday loan model is unaffordable for most
10	borrowers, leads to repeat borrowing, and promotes indebtedness
11	that is far longer than advertised.
12	The legislature further finds that there has been a shift
13	in the payday industry toward small dollar installment loans,
14	which are repayable over time and secured by access to the
15	borrower's checking account. According to the Pew Charitable
16	Trusts, national survey data indicates that seventy-nine per
17	cent of payday borrowers prefer small dollar loans that are due

- 1 in installments, which only take a small share of each paycheck.
- 2 However, in the absence of sensible regulatory safeguards, this
- 3 type of lending, as well as the traditional deferred deposit
- 4 lending market, can be harmful for consumers.
- 5 The legislature notes that there has been a growing trend
- 6 around the country to provide more consumer protections, which
- 7 benefit consumers and encourage responsible and transparent
- 8 lending, for deferred deposit transactions and small dollar
- 9 installment loans within the payday lending industry. Hawaii
- 10 has not yet joined in these reform efforts.
- 11 The legislature acknowledges that there is a market for
- 12 small dollar installment loans. However, the legislature
- 13 concludes that if small dollar installment loans are going to be
- 14 offered to Hawaii consumers, there must be appropriate consumer
- 15 protections in place to ensure these loans contain reasonable
- 16 terms and fees and do not trap borrowers in a cycle of high-
- 17 interest debt.
- 18 Accordingly, the purpose of this Act is to encourage
- 19 transparency and increase consumer protection in the payday
- 20 lending industry by:

1	(1)	Transitioning the payday lending industry from lump			
2		sum deferred deposit transactions to installment-based			
3		small dollar loan transactions;			
4	(2)	Specifying various consumer protection requirements			
5		for small dollar loans;			
6	(3)	Beginning January 1, 2019, requiring licensure for			
7		small dollar lenders that offer small dollar loans to			
8		consumers; and			
9	(4)	Specifying licensing requirements for small dollar			
10		lenders.			
11	SECTION 2. The Hawaii Revised Statutes is amended by				
12	adding a	new chapter to title 25A to be appropriately designated			
13	and to rea	ad as follows:

- 2 monthly maintenance fees authorized by this chapter, shall be
- 3 included in the calculation of the annual percentage rate.
- 4 "Arranger" means a provider of funds in the syndication of
- 5 a debt.
- 6 "Branch office" means any location in this State that is
- 7 identified by any means to the public or customers as a location
- 8 at which the licensee holds itself out as a small dollar lender.
- 9 "Commissioner" means the commissioner of financial
- 10 institutions.
- "Consumer" means a natural person who is the buyer, lessee,
- 12 or debtor to whom credit is granted in a transaction that is
- 13 primarily for that natural person's personal, family, or
- 14 household purposes.
- "Control", in the context of control of an applicant or
- 16 licensee, means ownership of, or the power to vote, twenty-five
- 17 per cent or more of the outstanding voting securities of a
- 18 licensee or controlling person. For the purposes of determining
- 19 the percentage of an applicant or a licensee controlled by any
- 20 person, there shall be aggregated with the controlling person's

- 1 interest the interest of any other person controlled by the
- 2 person, or by any spouse, parent, or child of the person.
- 3 "Controlling person" means any person in control of a
- 4 licensee or applicant.
- 5 "Default" means a consumer's failure to repay a small
- 6 dollar loan in compliance with the terms contained in a small
- 7 dollar loan agreement.
- 8 "Department" means the department of commerce and consumer
- 9 affairs.
- 10 "Division" means the division of financial institutions of
- 11 the department of commerce and consumer affairs.
- "Elder" means a person who is sixty-two years of age or
- 13 older.
- 14 "Finance charges" means the cost of credit or cost of
- 15 borrowing, including the interest, monthly maintenance fees, and
- 16 other fees authorized by this chapter.
- 17 "Financial institution" means any bank, savings bank,
- 18 savings and loan association, financial services loan company,
- 19 or credit union doing business in the State whose accounts are
- 20 insured by the Federal Deposit Insurance Corporation, the

- 1 National Credit Union Share Insurance Fund, or other similar or
- 2 successor program of federal insurance.
- 3 "Instrument" means a personal check signed by the consumer
- 4 and made payable to a person subject to this chapter. The term
- 5 "instrument" does not include an electronic fund transfer or
- 6 other electronic debit or credit to the consumer's checking
- 7 account.
- 8 "Licensee" means a person who is licensed or required to be
- 9 licensed under this chapter.
- 10 "Loan amount" means the amount financed, as that term is
- 11 defined in Regulation Z of the Truth in Lending Act, title 12
- 12 Code of Federal Regulations, chapter X, part 1026, as amended,
- 13 or supplemented by this chapter.
- 14 "Maintenance fee" means a monthly fee paid to a licensee to
- 15 maintain a small dollar loan.
- 16 "NMLS" means a licensing system developed and maintained by
- 17 the Conference of State Bank Supervisors and the American
- 18 Association of Residential Mortgage Regulators for the state
- 19 licensing and registration of state-licensed loan originators
- 20 and other financial services providers, or any system provided
- 21 by the Consumer Financial Protection Bureau.

- 1 "Person" means an individual, sole proprietorship,
- 2 partnership, corporation, limited liability company, limited
- 3 liability partnership, or other association of individuals,
- 4 however organized.
- 5 "Place of business" means a location where small dollar
- 6 loans are offered or made and includes each website through
- 7 which a consumer may apply for a small dollar loan from a small
- 8 dollar lender.
- 9 "Precomputed interest" means an interest method that uses
- 10 the original payment schedule to calculate interest.
- "Small dollar lender" or "lender" means any person who is
- 12 in the business of offering or making a consumer loan, who
- 13 arranges a consumer loan for a third party, or who acts as an
- 14 agent for a third party, regardless of whether the third party
- 15 is exempt from licensure under this chapter or whether approval,
- 16 acceptance, or ratification by the third party is necessary to
- 17 create a legal obligation for the third party, through any
- 18 method including mail, telephone, the Internet, or any
- 19 electronic means.
- 20 "Small dollar loan" means a loan made pursuant to this
- 21 chapter.

- 1 (e) The commissioner may biennially adjust for inflation 2 the total amount of the small dollar loan permitted under 3 subsection (a)(2) or the total maintenance fee permitted under 4 subsection (a)(5); provided that the commissioner's ability to 5 adjust the total maintenance fee shall be limited to adjusting 6 the maximum dollar amount of the fee and shall not extend to 7 adjusting the way the total maintenance fee is calculated; 8 provided further that any amounts adjusted pursuant to this 9 subsection shall be published on the division's website. - 6 (c) Loans shall be repayable in substantially equal and
- 7 consecutive monthly installments of principal and interest
- 8 combined; provided that the first installment period may exceed

- 10 installment payment amount may be larger than the remaining
- 11 payments by the amount of interest charged for the extra days;

13	§ -8 Renewal; new loan requirements; consecutive loans;			
14	payment plan. (a) A small dollar loan may be renewed only			
15	once. After one renewal, the consumer shall pay the debt in			
16	cash or its equivalent.			
17	(b) Upon renewal of a small dollar loan, the lender may			
18	renew up to \$1,000 of the remaining unpaid balance. If the			
19	unpaid balance on renewal is more than \$1,000, the consumer may			
20	be required to pay the remaining balance; provided that the			
21	lender shall not finance any amount over \$1,000. The total			

- 1 amount of fees and charges for the renewed loan shall meet the
- 2 requirements of section -2. If the small dollar loan is
- 3 renewed prior to the maturity date, the lender shall refund to
- 4 the consumer a prorated portion of the finance charge based upon
- 5 the ratio of time left before maturity to the loan term.
- 6 (c) Once the consumer has paid off the small dollar loan
- 7 transaction, the consumer may enter into a new small dollar loan
- 8 agreement with the lender; provided that the lender shall not
- 9 have more than one outstanding loan with a borrower at any one
- 10 time, pursuant to section -5.
- 11 § -9 Form of loan proceeds. A small dollar lender may
- 12 pay the proceeds from a small dollar loan to the consumer in the
- 13 form of a monetary instrument, money order, or cash. The lender
- 14 shall inform the consumer in writing that the lender shall cash
- 15 the monetary instrument or money order at no cost to the
- 16 consumer.
- 17 § -10 Endorsement of instrument. A small dollar lender
- 18 shall not negotiate or present an instrument for payment unless
- 19 the instrument is endorsed with the actual business name of the
- 20 lender.

- 1 § -11 Redemption of instrument. Prior to a small dollar
- 2 lender negotiating or presenting the instrument, a consumer
- 3 shall have the right to redeem any instrument held by the lender
- 4 as a result of a small dollar loan if the consumer pays the full
- 5 amount of the instrument to the lender.
- 6 § -12 Delinquent small dollar loans; restrictions on
- 7 collection by lender or third party. (a) A small dollar lender
- 8 shall comply with all applicable state and federal laws when
- 9 collecting a delinquent small dollar loan. A lender may take
- 10 civil action to collect principal, interest, fees, and costs
- 11 allowed under this chapter. A lender may not threaten criminal
- 12 prosecution as a method of collecting a delinquent small dollar
- 13 loan or threaten to take any legal action against the consumer
- 14 that is not otherwise permitted by law.
- 15 (b) Unless invited by the consumer, a lender shall not
- 16 visit a consumer's residence or place of employment for the
- 17 purposes of collecting a delinquent small dollar loan. A lender
- 18 shall not impersonate a law enforcement officer or make any
- 19 statements that might be construed as indicating an official
- 20 connection with any federal, state, or county law enforcement

- agency or any other governmental agency while engaged in
 collecting a small dollar loan.
- 3 (c) A lender shall not communicate with a consumer in a
- 4 manner intended to harass, intimidate, abuse, or embarrass a
- 5 consumer, including but not limited to communication at an
- 6 unreasonable hour, with unreasonable frequency, by threats of
- 7 force or violence, or by use of offensive language. A
- 8 communication shall be presumed to have been made for the
- 9 purposes of harassment if it is initiated by the lender for the
- 10 purposes of collection and the communication is made:
- 11 (1) With the consumer's spouse or the consumer's domestic
- partner in any form, manner, or place, more than once;
- 13 (2) With a consumer at the consumer's place of employment
- more than once;
- 15 (3) With the consumer, the consumer's spouse, or the
- 16 consumer's domestic partner at the consumer's place of
- residence between the hours of 9:00 p.m. and
- 18 8:00 a.m.; or
- 19 (4) To a party other than the consumer, the consumer's

- 2 small dollar lender offering a small dollar loan shall
- 3 conspicuously and continuously post at any place of business
