A BILL FOR AN ACT

RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the United States 1 2 Peace Corps has had many individuals with the potential to serve in other federal, state, or local government sectors once their 3 4 service is completed. Since many returned Peace Corps volunteers have teaching backgrounds as well as unique work or 5 life experiences, they would be valuable to add to the state and 6 7 county network of employees, including those in the department of education. As Hawaii is currently experiencing a shortage of 8 teachers, former returned Peace Corps volunteers have the 9 potential to fill teaching vacancies in the State. 10

Having served in and experienced life in other countries, returned Peace Corps volunteers are able to add a unique global perspective that could be beneficial to the teaching profession. Allowing returned Peace Corps volunteers to earn service credit in the employees' retirement system for their time in the Peace Corps would serve as an incentive for them to remain in Hawaii for several years and continue to accrue benefits.
