## A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the importance of

2 computer science cannot be overstated. For example, fifty per

3 cent of Americans rank computer science as one of the most

4 important subjects of study, after reading and writing, and

5 seventy-five per cent of Americans believe computer science is

7 The legislature further finds that computing-based

8 occupations make up more than two-thirds of all projected new

9 jobs in the science, technology, engineering, and mathematics

10 fields, commonly known as STEM fields. This means that college

graduates with computer science degrees are in high demand among

12 employers across the nation. Students who learn computer

13 science in high school are six times more likely to major in it

in college, and women who learn computer science in high school

15 are ten times more likely to major in it in college.

16 The legislature also finds that recent survey and research

17 results show a disparity between the demand for computer science

- 1 education and its availability. Although sixty-seven per cent
- 2 of parents and fifty-six per cent of teachers believe students
- 3 should be required to learn computer science, and ninety per
- 4 cent of parents want their children's schools to teach computer
- 5 science, only forty per cent of schools offer these courses.
- 6 Further, although seventy-one per cent of new STEM jobs are in
- 7 computing, only eight per cent of STEM graduates hold degrees in
- 8 computer science.
- 9 The legislature concludes that there are similar
- 10 disparities at the State level, where computer science has the
- 11 potential to drive job growth and innovation throughout the
- 12 economy. As of December 2016, there were 1,343 open computing
- 13 jobs in Hawaii, and the average salary for these computing jobs
- 14 was \$78,414, which is much higher than the state average salary
- 15 of \$47,740. However, only one hundred fifty-five Hawaii
- 16 students graduated with a computer science degree in 2014, and
- 17 only fourteen schools in Hawaii offered the advanced placement
- 18 computer science course in 2015-2016. The legislature finds
- 19 that promoting computer science education is a matter of
- 20 statewide concern.

- 3 The sum appropriated shall be expended by the department of
- 4 education for the purposes of this Act.
- 5 SECTION 4. The appropriation authorized under this Act
- 6 shall not lapse at the end of the fiscal year for which the
- 7 appropriation is made. Any unexpended and unencumbered balance
- 8 of the appropriation made in this Act as of the close of
- 9 business on June 30, 2019, shall lapse.
- 10 SECTION 5. New statutory material is underscored.
- 11 SECTION 6. This Act shall take effect on July 1, 2050.
