### A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR HE'EIA NATIONAL ESTUARINE RESEARCH RESERVE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The national estuarine research reserve system
- 2 is a network of twenty-eight protected areas along America's
- 3 coasts. According to the National Estuarine Research Reserve
- 4 System Strategic Plan 2011-2016, the system is founded on the
- 5 principle that long-term protection of representative estuaries
- 6 provides stable platforms for research and education and the
- 7 application of management practices that will benefit the
- 8 nation's estuaries and coasts.
- 9 The legislature finds that the State has coordinated with
- 10 the National Oceanic and Atmospheric Administration (NOAA) to
- 11 nominate He'eia estuary as a national estuarine research reserve.
- 12 The site, located on Oahu's windward shore, includes He'eia state
- 13 park, He'eia fishpond, and the He'eia community development
- 14 district, as well as marine waters with patch and fringing reefs
- 15 and Moku o Lo'e (Coconut Island). In 2012, the office of
- 16 planning was designated as the lead agency to coordinate the

- 1 selection for a Hawaii site to be designated as a national
- 2 estuarine research reserve and nomination process for He'eia to
- 3 be designated as a national estuarine research reserve. In
- 4 2014, He'eia was officially nominated as a national estuarine
- 5 research reserve to support NOAA's policy to encourage expansion
- 6 of the program in unrepresented areas of the country.
- 7 The He'eia site was chosen as the preferred site after a
- 8 statewide solicitation period from interested communities. The
- 9 office of planning supported the designation process through the
- 10 development of the He'eia national estuarine research reserve
- 11 system management plan. On January 19, 2017, the He'eia site was
- 12 officially designated as the twenty-ninth site in the national
- 13 estuarine research reserve system, which enables federal funding
- 14 to support the implementation of the management plan.
- 15 The Hawaii institute of marine biology, which is part of
- 16 the University of Hawaii at Manoa, is the lead agency for
- 17 implementation of the He'eia national estuarine research reserve
- 18 system management plan. The University's partners will include
- 19 the Hawaii community development authority, department of land
- 20 and natural resources, and several community organizations. For
- 21 He'eia reserve to succeed in its function within the national

- 1 estuarine research reserve system, funding for initial staffing
- 2 is essential. The initial staffing needs are four full-time
- 3 equivalent (4.0 FTE) positions: reserve manager, education
- 4 coordinator, research coordinator, and cultural resource
- 5 coordinator. Although the University of Hawaii has agreed to
- 6 fund these positions in the first year, further funding is
- 7 required to sustain them and to keep He'eia reserve fully
- 8 functioning. These positions must be established and sustained
- 9 to develop and manage He'eia reserve and keep it fully
- 10 functioning. The legislature notes that as funding or
- 11 partnership opportunities become available, additional staff
- 12 will be required within the first five years to meet management
- 13 plan goals and objectives, and further notes that the federal
- 14 government matches state appropriations on a seventy per cent
- 15 (federal) to thirty per cent (state) basis.
- 16 The purpose of this Act is to support He'eia estuary in its
- 17 designation as a national estuarine research reserve by
- 18 appropriating funds to maintain the initial staff necessary to
- 19 develop and manage He'eia reserve and its programs.
- 20 SECTION 2. Contractors and other third parties who receive
- 21 funds under this Act may be subject to review and inspection by

- 1 the department of land and natural resources, the attorney
- 2 general, and the auditor. Upon request by such agencies, the
- 3 contractor or third party shall be required to submit for review
- 4 all files, records, documents, and accounting related to the use
- 5 and expenditure of funds received pursuant to this Act, whether
- 6 the funds were received via contract, grant, or other agreement.
- 7 SECTION 3. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so much
- 9 thereof as may be necessary for fiscal year 2018-2019 for the
- 10 hiring of full-time equivalent ( FTE) permanent
- 11 positions within the University of Hawaii to maintain the
- 12 initial staff positions that are necessary to develop and manage
- 13 He'eia reserve and its programs.
- 14 The sum appropriated shall be expended by the University of
- 15 Hawaii for the purposes of this Act.
- 16 SECTION 4. This Act shall take effect on December 24,
