A BILL FOR AN ACT

RELATING TO THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that consumption of fresh 2 fruits and vegetables is an integral part of a healthy diet and
- 3 central to the prevention of obesity and disease. Every
- 4 community should have adequate access to fresh and healthy
- 5 dietary options. However, the high cost and poor quality of
- 6 nearby fresh produce often make this difficult for some
- 7 communities.
- 8 The legislature further finds that, to increase access to
- 9 fresh fruits and vegetables for beneficiaries of the federal
- 10 Supplemental Nutrition Assistance Program, some states have
- 11 enacted farmers' market matching incentive programs. Under such
- 12 programs, individuals who purchase produce at local farmers'
- 13 markets using their nutrition assistance benefits receive
- 14 additional benefits on a dollar-for-dollar basis up to a certain
- 15 amount.
- 16 The legislature concludes that farmers' market matching
- 17 incentive programs have not only increased access to healthy

- 1 dietary options, but have also helped invigorate local economies
- 2 and address food insecurity. Previous legislation introduced in
- 3 Hawaii to establish a similar program was supported by community
- 4 and scientific groups.
- 5 The purpose of this Act is to require the department of
- 6 agriculture to develop and administer a farmers' market matching
- 7 incentive program promoting the purchase of Hawaii-grown fruits
- 8 and vegetables for beneficiaries of the Supplemental Nutrition
- 9 Assistance Program.
- 10 SECTION 2. Chapter 141, Hawaii Revised Statutes, is
- 11 amended by adding a new section to be appropriately designated
- 12 and to read as follows:
- 13 "§141- Farmers' market matching incentive program;
- 14 special fund. (a) There is established a farmers' market
- 15 matching incentive program for beneficiaries of the Supplemental
- 16 Nutrition Assistance Program. The program shall be developed
- 17 and administered by the department of agriculture.
- 18 (b) Beneficiaries of the Supplemental Nutrition Assistance
- 19 Program who use food stamps to make purchases at a farmers'
- 20 market shall receive a dollar-for-dollar match up to \$
- 21 to be used exclusively for purchases at a farmers' market.

- 1 "Farmers' market" shall have the same meaning as in section
- **2** 205-2(d)(15)(D).
- 3 (c) There is established within the department of
- 4 agriculture a farmers' market matching incentive program special
- 5 fund, into which shall be deposited any legislative
- 6 appropriations and any public or private grants, awards, or
- 7 gifts for the purpose of the farmers' market matching incentive
- 8 program. Moneys in the special fund may be expended by the
- 9 department to administer the program and to provide matching
- 10 funds to beneficiaries.
- 11 (d) The department of agriculture may cooperate with
- 12 private organizations to develop rules for the farmers' market
- 13 matching incentive program."
- 14 SECTION 3. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so much
- 16 thereof as may be necessary for fiscal year 2018-2019 to be
- 17 deposited into the farmers' market matching incentive program
- 18 special fund.
- 19 SECTION 4. There is appropriated out of the farmers'
- 20 market matching incentive program special fund the sum of
- 21 \$ or so much thereof as may be necessary for fiscal year

- 1 2018-2019 for administration of the farmers' market matching
- 2 incentive program and to provide matching funds to beneficiaries
- 3 of the Supplemental Nutrition Assistance Program.
- 4 The sum appropriated shall be expended by the department of
- 5 agriculture for the purposes of this Act.
- 6 SECTION 5. New statutory material is underscored.
- 7 SECTION 6. This Act shall take effect on July 1, 3000.
