## A BILL FOR AN ACT

RELATING TO THE ARTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Chapter 201, Hawaii Revised Statutes, is SECTION 1. 2 amended by adding a new part to be appropriately designated and to read as follows: 3 4 "PART . CREATIVE DISTRICTS 5 §201-A Definitions. As used in this part: 6 "Department" means the department of business, economic 7 development, and tourism. 8 "Director" means the director of business, economic 9 development, and tourism. 10 "Coordinator" means the individual designated by the 11 director to perform the specific tasks under this part. 12 "Creative district" means an area designated as a creative 13 district by a county. 14 §201-B Creative district; designation. - 8 SECTION 4. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so much

- 12 The sum appropriated shall be expended by the department of
- 13 business, economic development, and tourism for the purposes of
- 14 this Act.
- 15 SECTION 5. In codifying the new sections added by section
- 16 1 of this Act, the revisor of statutes shall substitute
- 17 appropriate section numbers for the letters used in designating
- 18 the new sections in this Act.
- 19 SECTION 6. This Act shall take effect on July 1, 2018.
