

A BILL FOR AN ACT

MAKING AN APPROPRIATION TO THE DEPARTMENT OF EDUCATION FOR THE NEW HIGH SCHOOL IN KIHEI.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that south Maui County
- 2 currently lacks a high school. Significant population growth in
- 3 this area, particularly in the Kihei-Makena region, along with
- 4 geographical separation from existing central Maui high schools,
- 5 has created a need for a new high school in south Maui.
- 6 Students in Kihei must travel long distances to attend high
- 7 school in central Maui. Furthermore, the lack of a high school
- 8 in the south Maui area has raised enrollment at two central Maui
- 9 schools, Maui high school and Baldwin high school, such that
- 10 each of those schools has surpassed its respective design
- 11 capacity and is now overcrowded.
- 12 The legislature also finds that it has previously
- 13 appropriated funds to cover all costs for the planning, design,
- 14 and construction of a new high school in Kihei. In 2013, the
- 15 legislature appropriated \$130,000,000 for the completion of the
- 16 project. However, due to fiscal concerns and changes in

- 1 administration, the department of education was unable to spend
- 2 \$100,000,000 of the appropriated funds. In response, the
- 3 department adopted a phased approach for the project. The first
- 4 phase of the project would include the necessary infrastructure
- 5 construction and the second phase would include the construction
- 6 of the new school's physical buildings.
- 7 The legislature additionally finds that it has secured
- 8 \$30,000,000 in funds for the first phase of the project. The
- 9 securing of these funds allowed the department to commence the
- 10 infrastructure construction of the first phase and break ground
- 11 on the new Kihei high school in January 2016.
- 12 The legislature further finds that an appropriation of
- 13 funds for the second phase of the Kihei high school project is
- 14 necessary at this time so that the remaining planning, design,
- 15 and construction work on the second phase may move forward
- 16 without further delay. While the design of this unique school
- 17 has taken some additional time, the school's well-planned and
- 18 strategic innovations will optimize the benefits provided to
- 19 students and the community. When complete, the new high school
- 20 will feature an innovative, eco-friendly design that will take
- 21 full advantage of the building site and accompanying natural

- 1 resources. The new school is designed as the first net-zero
- 2 energy school in the State and it will incorporate site-
- 3 appropriate eco-strategies that will allow for continuous use of
- 4 indoor and outdoor learning spaces.
- 5 The legislature also finds that the new Kihei high school
- 6 project has been in the planning stages for nearly a decade and
- 7 current estimates from the department of education indicate that
- 8 the new school will not open before 2022. Given the
- 9 overcrowding in central Maui schools and the ever-increasing
- 10 population in the Kihei-Makena region, additional delays in
- 11 construction of the new Kihei high school will continue to
- 12 negatively impact students and community members of south Maui.
- 13 Accordingly, the purpose of this Act is to authorize the
- 14 appropriation of \$123,000,000 for the funding of the second
- 15 phase of the planning, design, and construction of the new high
- 16 school in Kihei, Maui.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$123,000,000 or so
- 19 much thereof as may be necessary for fiscal year 2017-2018 and
- 20 the same sum or so much thereof as may be necessary for fiscal
- 21 year 2018-2019 for the department of education for completing

- 1 the planning, design, and construction for the second phase of
- 2 the new high school in Kihei, Maui.
- 3 The sums appropriated shall be expended by the department
- 4 of education for the purposes of this Act.
- 5 SECTION 3. This Act shall take effect on July 1, 2017.
