### A BILL FOR AN ACT

RELATING TO HIGHWAY SAFETY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 291E-61, Hawaii Revised Statutes, is SECTION 1. amended by amending subsection (b) to read as follows: 2 3 "(b) A person committing the offense of operating a vehicle under the influence of an intoxicant shall be sentenced 4 without possibility of probation or suspension of sentence as 5 6 follows: 7 For the first offense, or any offense not preceded (1)within a five-year period by a conviction for an 8
