
HOUSE CONCURRENT RESOLUTION

URGING THE UNIVERSITY OF HAWAII TO TAKE ALL NECESSARY ACTION TO
TRANSFER THE OPERATION AND LANDS OF WAIALEE LIVESTOCK
EXPERIMENT STATION TO THE AGRIBUSINESS DEVELOPMENT
CORPORATION.

1 WHEREAS, the Hawaii State Planning Act sets as an economic
2 objective of the State, an agricultural industry that continues
3 to constitute a dynamic and essential component of Hawaii's
4 strategic, economic, and social wellbeing; and
5

6 WHEREAS, the purpose of Chapter 163D, Hawaii Revised
7 Statutes, is to establish the Agribusiness Development
8 Corporation and the process to make optimal use of agricultural
9 assets for the economic, environmental, and social benefit of
10 the people of Hawaii; and
11

12 WHEREAS, the University of Hawaii College of Tropical
13 Agriculture and Human Resources (CTAHR) is a critical component
14 in the development, growth, and sustainability of Hawaii's
15 agricultural sector; and
16

17 WHEREAS, CTAHR administers the Waialeale Livestock Experiment
18 Station (Waialeale) on the north shore of the island of Oahu; and
19

20 WHEREAS, Waialeale is an animal research and demonstration
21 facility located on one hundred thirty-five acres of state-owned
22 land of which approximately sixty-five acres are fenced and
23 thirty-five acres have the potential to be irrigated; and

25 WHEREAS, Waialeale's facilities include an office space,
26 slaughterhouse, feed storage, and mixing facility, and animal
27 housing for pigs, poultry, swine, and cattle; and

1 WHEREAS, Waialeale also includes grazing pastures and an
2 experimental waste to biogas demonstration facility; and
3

4 WHEREAS, the lands and the facilities of Waialeale are
5 compatible with and would effectively and efficiently further
6 the achievement of the purposes and objectives of the
7 Agribusiness Development Corporation; now, therefore,
8

9 BE IT RESOLVED by the House of Representatives of the
10 Twenty-ninth Legislature of the State of Hawaii, Regular Session
11 of 2018, the Senate concurring, that the University of Hawaii is
12 urged to take all necessary action to transfer the operation and
13 lands of Waialeale Livestock Experiment Station to the
14 Agribusiness Development Corporation; and

16 BE IT FURTHER RESOLVED that certified copies of this
17 Concurrent Resolution be transmitted to the Governor,
18 Chairperson of the Board of Regents and President of the
19 University of Hawaii, Chairperson of the Board of Directors and
20 Executive Director of the Agribusiness Development Corporation,
21 and the Dean of the College of Tropical Agriculture and Human
22 Resources.
