
HOUSE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND
TOURISM TO AMEND ITS MISSION STATEMENT TO EXPRESSLY INCLUDE
THE DEVELOPMENT OF A BUSINESS FRIENDLY CULTURE IN THE
STATE.

1 WHEREAS, the Department of Business, Economic Development,
2 and Tourism is the primary agency tasked with promoting business
3 and economic development in the State; and

5 WHEREAS, the primary objectives of the department are to
6 create broad policy determinations with respect to economic
7 development in the State and to stimulate opportunities that
8 offer the most immediate promise of expanding the State's
9 economy; and
10

11 WHEREAS, supporting existing and emerging businesses;
12 attracting new investment and businesses that can create more
13 skilled, quality jobs in the State; and working to increase
14 exports of state products and services are critical to economic
15 development in the State; and

17 WHEREAS, in order for existing and emerging businesses to
18 thrive in the State, and to attract new businesses, the State
19 must promote a business friendly culture; and

21 WHEREAS, the mission statement of the department is a
22 declaration of department priorities and sets the tone for the
23 work of the department, department staff, and the State; and

25 WHEREAS, the department's current mission statement is "to
26 support the development of a Hawaii economy that embraces
27 innovation; an economy that is globally competitive, dynamic,
28 and productive; and provides opportunities for all Hawaii's
29 citizens"; and

1 WHEREAS, it is important that the department expressly
 2 include in its mission statement the development of a business
 3 friendly culture in the State; now, therefore,

 5 BE IT RESOLVED by the House of Representatives of the
 6 Twenty-ninth Legislature of the State of Hawaii, Regular Session
 7 of 2018, the Senate concurring, that the Department of Business,
 8 Economic Development, and Tourism is urged to amend its mission
 9 statement to expressly include the development of a business
 10 friendly culture in the State; and

 12 BE IT FURTHER RESOLVED that the department is urged to
 13 consider adopting a mission statement that reads: "The
 14 Department of Business, Economic Development, and Tourism's
 15 mission is to support the development of a Hawaii economy that
 16 is business friendly, embraces innovation; an economy that is
 17 globally competitive, dynamic, and productive; and provides
 18 opportunities for all Hawaii's citizens."; and

 20 BE IT FURTHER RESOLVED that certified copies of this
 21 Concurrent Resolution be transmitted to the Governor and the
 22 Director of Business, Economic Development and Tourism.
