## HOUSE CONCURRENT RESOLUTION

---

RECOGNIZING MARCH 19 AS HAWAII CELEBRATING WOMEN IN PUBLIC  
OFFICE DAY.

1 WHEREAS, the month of March is Women's History Month and  
2 celebrates the significant contributions women of all races,  
3 ethnicities, and backgrounds have made to the world; and

5 WHEREAS, while the twentieth century was a pivotal time of  
6 growth for women entering politics, a 2017 study by the Center  
7 for American Women and Politics at Rutgers University shows that  
8 women hold less than twenty percent of seats in the 115th U.S.  
9 Congress, twenty-four percent of elective executive offices, and  
10 twenty-five percent of seats in state legislatures in the United  
11 States; and

13 WHEREAS, women remain underrepresented in male-dominated  
14 fields; thus, providing opportunities to support women in public  
15 office is imperative; and

17 WHEREAS, women play a critical role in the vitality and  
18 diversity of our communities and are essential to ensuring  
19 Hawaii is well represented; and

21 WHEREAS, Hawaii is ranked as one of the best states in  
22 terms of women's representation in elected offices at the state  
23 and national level; and

25 WHEREAS, the recent surge and success of women candidates  
26 running for public office in New Jersey and Virginia have  
27 created momentum for a movement of women running for office; and

29 WHEREAS, recognizing women in public office will bring  
30 awareness to the fundamental necessity of their work and will  
31 inspire other young people to serve their communities; now,
