
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF THE ATTORNEY GENERAL TO CONVENE A TWO-YEAR WORKING GROUP TO DETERMINE THE BEST WAY TO PROTECT THE RIGHTS OF SURROGATES, GESTATIONAL CARRIERS, INTENDED PARENTS, AND CHILDREN.

1 WHEREAS, many people have a strong desire to be a parent
2 despite being unable to bear a child; and
3

4 WHEREAS, surrogacy arrangements, in which a woman agrees to
5 become pregnant, carry, and give birth to a child for another
6 intended parent, occur in Hawaii, but the frequency and means of
7 these agreements are unknown; and
8

9 WHEREAS, there are neither prohibitions nor protections for
10 surrogate parents and intended parents with regard to surrogacy
11 or gestational carrier agreements in Hawaii; and
12

13 WHEREAS, the lack of regulation in this State regarding
14 surrogacy may create inconsistent legal results and inadequate
15 protections among surrogates and intended parents; and
16

17 WHEREAS, the issue of surrogacy in Hawaii should be
18 studied, and if appropriate, laws to regulate surrogacy and
19 protect the parties to surrogacy arrangements should be enacted;
20 now, therefore,
21

22 BE IT RESOLVED by the House of Representatives of the
23 Twenty-ninth Legislature of the State of Hawaii, Regular Session
24 of 2018, the Senate concurring, that the Department of the
25 Attorney General is requested to convene and lead a surrogacy
26 working group for the purposes of considering whether the State
27 should regulate surrogacy; and

1 BE IT FURTHER RESOLVED that the Department of the Attorney
2 General is requested to seek input for the surrogacy working
3 group from community partners, including:

- 5 (1) The Department of Health;
- 6
- 7 (2) The Department of Human Services;
- 8
- 9 (3) The Judiciary;
- 10
- 11 (4) The Hawaii State Bar Association, especially members
12 who have handled a surrogacy matter;

- 14 (5) Advocates or representatives of surrogates;
- 15
- 16 (6) Advocates or representatives of gestational carriers;
- 17
- 18 (7) Advocates or representatives of intended parents; and
- 19
- 20 (8) Advocates or representatives of children; and

22 BE IT FURTHER RESOLVED that the working group is requested
23 to consider, at a minimum:

- 25 (1) What kind of surrogacy should be allowed and
26 regulated, if any;
- 27
- 28 (2) Whether Hawaii should enact laws modeled on those of
29 other states or the Uniform Parentage Act;
- 30
- 31 (3) How to prevent the financial exploitation of women in
32 surrogacy matters;
- 33
- 34 (4) The minimum requirements for a valid surrogacy
35 agreement;
- 36
- 37 (5) What legal presumptions, if any, should apply
38 regarding surrogacies;

- 40 (6) How legal presumptions of parenthood should apply to
41 parents of the same sex;

1 (7) Whether a person with a genetic relationship to a
2 child should be able to rebut parentage presumptions
3 based on marriage;
4

5 (8) What statistical information should be collected for
6 the birth certificate, and which parents should be
7 identified on the birth certificate of a child born
8 via surrogacy; and
9

10 (9) Whether the working group should coordinate its
11 suggestions to revise Chapter 584, Hawaii Revised
12 Statutes; and
13

14 BE IT FURTHER RESOLVED that the working group shall be
15 informal and shall meet at the discretion of the Attorney
16 General or the Attorney General's designee and shall not be
17 subject to the requirements of Chapter 92, Hawaii Revised
18 Statutes; and

20 BE IT FURTHER RESOLVED that the working group is requested
21 to report its progress, along with any preliminary
22 recommendations, to the Legislature no later than twenty days
23 prior to the convening of the Regular Session of 2019; and
24

25 BE IT FURTHER RESOLVED that the working group submit a
26 final report of its findings, including any proposed
27 legislation, or a report explaining why no legislation is
28 required, to the Legislature no later than twenty days prior to
29 the convening of the Regular Session of 2020; and
30

31 BE IT FURTHER RESOLVED that the surrogacy working group
32 cease to exist on June 30, 2020; and
