BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 612-6, Hawaii Revised Statutes, is
2	amended t	o read as follows:
3	"§ 61	2-6 Exempt when. A person may claim exemption from
4	service a	s a juror if the person is:
5	(1)	An elected official while the legislature is in
6		session, or a judge of the United States, State, or
7		county;
8	(2)	An actively practicing physician or dentist;
9	(3)	A member of the armed forces or militia when on active
10		service and deployed out-of-state;
11	(4)	An active member of a police or fire department;
12	(5)	A person who has served as a juror, either in a court
13		of this State or the United States District Court for
14		the District of Hawaii, within one year preceding the
15		time of filling out the juror qualification form;

16 (6) An active member of an emergency medical services

1	(7) A person living more than [seventy] miles from		
2	the court for which jury service is required;		
3	(8) A person eighty years of age or older; or		
4	(9) A woman who is breastfeeding a child or expressing		
5	breast milk for a period of two years from the birth		
6	of the child.		
7	For purposes of this section, "emergency medical services		
8	agency" means any government agency, private agency, or company		
9	that provides ambulance services, emergency medical services, or		
10	disaster medical services."		
11	SECTION 2. Section 612-8, Hawaii Revised Statutes, is		
12	amended by amending subsection (a) to read as follows:		
13	"(a) Each juror or prospective juror shall be paid \$30 for		
14	each day of actual attendance at court. In addition, each juror		
15	or prospective juror shall be paid the higher of either:		
16	(1) $[33]$ 45 cents for each mile actually and necessarily		
17	traveled in going to and from court; or		
18	(2) The cost of an adult bus fare to and from the court.		
19	A person who appears at the time for which that person is		
20	summoned to court for jury duty may be allowed the mileage fee

or bus fare although the person, upon that person's request, is
 subsequently excused or exempted from jury service."

3 SECTION 3. Statutory material to be repealed is bracketed4 and stricken. New statutory material is underscored.

5 SECTION 4. This Act shall take effect on July 1, 2017.
