BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 302D, Hawaii Revised Statutes, is 2 amended by adding two new sections to be appropriately 3 designated and to read as follows: 4 "§302D-Commingling of moneys for charter school 5 operation; prohibited. Federal or state moneys distributed to a 6 nonprofit organization that operates a charter school and which 7 are earmarked for operations shall not be commingled with any 8 other moneys held by the nonprofit organization unless the other 9 moneys have an educational purpose that benefit the charter 10 school. 11 §302D-Limitation of liability. No action of a charter 12 school or its governing board shall give rise to a private cause 13 of action against the State." 14 SECTION 2. Section 302D-12, Hawaii Revised Statutes, is 15 amended by amending subsection (1) to read as follows: 16 "(1) Governing boards shall have the power to make and 17 execute contracts and all other instruments necessary or

Any contract entered into by a governing board in 2 excess of a minimum amount shall include conditions and 3 provisions as provided by the department of the attorney 4 general; provided that: 5 (1) The minimum amount shall be determined by the 6 commission through rules adopted pursuant to chapter 7 91; and 8 (2) Any contract that requires conditions and provisions 9 pursuant to this subsection and does not include the 10 required conditions and provisions shall be null and 11 void." 12 SECTION 3. For the purposes of section 302D-12(1), Hawaii 13 Revised Statutes, as amended by section 2 of this Act, the 14 minimum contract amount shall be \$10,000 until such time as the 15 state public charter school commission determines a minimum 16 amount through rules adopted pursuant to chapter 91, Hawaii 17 Revised Statutes. 18 SECTION 4. New statutory material is underscored. 19 SECTION 5. This Act shall take effect upon its approval.
