A BILL FOR AN ACT

RELATING TO AQUATIC LIFE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that hundreds of thousands of saltwater fish and other aquatic life, such as invertebrates, are annually removed from their natural ocean habitat in Hawai'i to be kept in aquariums in homes throughout the state and country. These fish and other aquatic life are caught and sold as part of the aquarium trade industry for ornamentation and amusement, not for food purposes.

8 The legislature also finds that the state aquarium fish 9 permit authorizes the taking of an unlimited number of fish and 10 other aquatic life for commercial purposes, and up to two 11 thousand fish and other aquatic life annually for recreational 12 purposes, using nets and traps containing stretched netting of 13 less than two-inch mesh. While a fine mesh net or trap is not 14 required in order to remove aquatic life for aquarium purposes, 15 it is generally believed to be more effective than using other 16 gear that does not require a permit, as the mesh is tight enough 17 to keep fish from escaping. The fine mesh nets and traps can be

1 used both near the surface of the ocean and at depths reached by
2 scuba diving. Like humans, any fish caught deep below the
3 surface will need to decompress before being brought to the
4 surface. The fish is then put in a bucket or other storage
5 container to take to shore, where it will begin its journey
6 through various temporary tanks and diverse conditions to travel
7 across the State or to other parts of the globe.

8 The legislature further finds that, as a precautionary principle and since saltwater fish and other aquatic life are 9 not caught for food purposes, it is in the best interest of the 10 fish and other aquatic life, as well as of the reefs they 11 12 inhabit, that they remain in their natural environment, not confined in personal aquarium tanks. Therefore, the legislature 13 concludes that commercial fishing for aquarium fish in Hawai'i 14 15 should be phased out.

16 While prohibiting the issuance of new aquarium fish 17 permits, this Act will protect existing commercial aquarium fish 18 collecting businesses by allowing individuals holding aquarium 19 fish permits that have been issued or renewed within the past 20 five years to continue using those permits, provided that they 21 also possess a commercial marine license. These existing



permits will also be able to be transferred, for five years 1 after enactment of this Act, to other individuals who possess a 2 commercial marine license. Non-commercial collectors will be 3 able to continue collecting aquarium fish up to the existing 4 limit of five specimens per day without needing an aquarium fish 5 6 permit, provided that they do not use fine meshed traps, fine 7 meshed nets, throw nets, or other prohibited catch methods. This Act is not, however, intended to encourage residents 8 and tourists to go into the water to view or catch aquarium fish 9 10 unless sufficient safety measures and adequate environmental 11 precautions are taken. 12 The purpose of this Act is to: Restrict the taking of, for commercial purposes, 13 (1)14 aquatic life by any method of catch to those individuals who hold a valid, non-lapsed aquarium fish 15 16 permit and commercial marine license; Prohibit the department of land and natural resources 17 (2) 18 from issuing new aquarium fish permits to take aquatic 19 life for commercial or non-commercial purposes; 20 (3) Allow, for commercial purposes, existing aquarium fish 21 permits to be renewed by individuals possessing a

1 (2)] "Aquarium fish permit" means a permit issued by the [board] department of land and natural resources for 2 the use of fine mesh nets and traps, other than throw 3 4 nets, to take salt water fish, freshwater nongame 5 fish, or other aquatic life for aquarium purposes. 6 "Aquarium purposes" means to hold salt water fish, 7 freshwater nongame fish, or other aquatic life alive in a state of captivity as pets, for scientific study, or for public 8 9 exhibition or display, or for sale for these purposes. 10 "Commercial purpose" has the same meaning as in section 11 187A-1. "Fine mesh", or "fine meshed", means stretched mesh of less 12 13 than two inches, as used in netting to collect fish and other 14 aquatic life. 6 SECTION 5. This Act shall take effect on July 1, 2018.

Report Title:

Aquarium Fish Permits; Commercial Marine License; Transfer or Renewal

Description:

Restricts the taking of aquatic life by any method for commercial purposes to individuals who hold a valid, non-lapsed aquarium fish permit and commercial marine license. Prohibits DLNR from issuing new aquarium fish permits. Requires DLNR to renew existing aquarium fish permits that have not lapsed for commercial marine licenses and transfer existing aquarium fish permits to commercial marine licenses prior to July 1, 2023. Allows for the taking of aquatic life for non-commercial purposes to a limit of five aquatic life specimens per permit per day, subject to certain conditions.
