A BILL FOR AN ACT

RELATING TO AQUATIC LIFE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1.	The legislature	finds	that	hundreds	of

- 2 thousands of saltwater fish and other aquatic life, such as
- 3 invertebrates, are annually removed from their natural ocean
- 4 habitat in Hawai'i to be kept in aquariums in homes throughout
- 5 the State and country. These fish and other aquatic life are
- 6 caught and sold as part of the aquarium trade industry for
- 7 ornamentation and amusement, not for food purposes.
- 8 The legislature also finds that the State's aquarium fish
- 9 permit authorizes the taking of an unlimited number of fish and
- 10 other aquatic life for commercial aquarium purposes, and up to
- 11 two thousand fish and other aquatic life annually for
- 12 recreational aquarium purposes, using nets and traps containing
- 13 stretched netting of less than two-inch mesh. While a fine mesh
- 14 net or trap is not physically required in order to remove
- 15 aquatic life for aquarium purposes, it is generally believed to
- 16 be more effective than using other gear that does not require a
- 17 permit, as the mesh is tight enough to keep fish from escaping.

- 1 The fine mesh nets and traps can be used both near the surface
- 2 of the ocean and at depths reached by scuba diving. The
- 3 legislature notes that for takings that do not require an
- 4 aquarium fish permit, there are generally no restrictions on the
- 5 number of fish and aquatic life that can be taken for aquarium
- 6 purposes. Like humans, any fish caught deep below the surface
- 7 will need to decompress before being brought to the surface.
- 8 The fish is then put in a bucket or other storage container to
- 9 take to shore, where it will begin its journey through various
- 10 temporary tanks and diverse conditions to travel across the
- 11 State or to other parts of the globe.
- 12 The legislature further finds that, as a precautionary
- 13 principle and since salt water fish and other aquatic life
- 14 caught for aquarium purposes are not used for food purposes, it
- 15 is in the best interest of the fish and other aquatic life, as
- 16 well as of the reefs they inhabit, that they remain in their
- 17 natural environment, not confined in aquarium tanks. Therefore,
- 18 the legislature concludes that aquarium fish collecting for
- 19 commercial purposes in Hawai'i should be phased out.
- 20 The legislature acknowledges the recent litigation in
- 21 Umberger v. Department of Land and Natural Resources, 140 Hawaii

- 1 500, 403 P.3d 277 (2017) and subsequent order after remand by
- 2 the circuit court issued on October 27, 2017, that resulted in
- 3 the invalidation of all existing aquarium fish permits used for
- 4 commercial aquarium collection purposes. The circuit court also
- 5 found that the department of land and natural resources'
- 6 practice of issuing commercial aquarium collection permits
- 7 without an environmental review as required by the Hawaii
- 8 Environmental Policy Act was a violation of that Act, and thus
- 9 enjoined the department from issuing or renewing aquarium fish
- 10 permits to commercial collectors until further order of the
- 11 circuit court. Collecting for recreational purposes was not
- 12 affected by the circuit court's order.
- 13 To phase out commercial collecting while also protecting
- 14 existing businesses, this Act will allow the department of land
- 15 and natural resources to issue new aquarium fish permits, to be
- 16 used for commercial purposes, during a four-month window
- 17 beginning on the lifting of the Umberger v. Department of Land
- 18 and Natural Resources injunction, if it is lifted. The
- 19 department of land and natural resources will be prohibited from
- 20 issuing new aquarium fish permits for commercial and non-
- 21 commercial purposes after that four-month window. Permits will

- 1 be able to be transferred for a period of five years to
- 2 commercial collectors who also possess a commercial marine
- 3 license. Non-commercial collectors, whether with nets or traps
- 4 allowed by the aquarium fish permit or by other means not
- 5 requiring an aquarium fish permit, will be held to the existing
- 6 collection limit of five aquatic specimens per day.
- 7 This Act is not, however, intended to encourage residents
- 8 and tourists to go into the water to view or catch aguarium fish
- 9 unless sufficient safety measures and adequate environmental
- 10 precautions are taken. Furthermore, this Act is not intended to
- 11 overrule the Hawai'i supreme court's decision in Umberger v.
- 12 Department of Land and Natural Resources and the subsequent
- 13 circuit court order upon remand, nor negate the State's
- 14 constitutional and statutory obligations to conserve fishery
- 15 resources in the State.
- 16 The purpose of this Act is to:
- 17 (1) Prohibit the department of land and natural resources
- from issuing new aquarium fish permits to take aquatic
- 19 life for commercial or non-commercial aquarium
- 20 purposes, except for a period of four months if the
- 21 injunction order as a result of Umberger v. Department

1		of Land and Natural Resources, if applicable, is
2		lifted;
3	(2)	Phase out the taking of aquatic life for commercial
4		aquarium purposes by any method of catch, though
5		allowing aquarium fish permits to be annually renewed
6		by individuals possessing a commercial marine license
7		and, for a period of five years after the injunction
8		order as a result of Umberger v. Department of Land
9		and Natural Resources, if applicable, is lifted,
10		transferrable to another individual who possesses a
11		commercial marine license;
12	(3)	Continue to allow the taking of aquatic life for non-
13		commercial aquarium purposes using certain nets or
14		traps with an aquarium fish permit, and clarify that
15		non-commercial aquarium collecting by any method of
16		catch is subject to a limit of five fish or aquatic
17		life specimens per person, per day; and
18	(4)	Allow a commercial marine licensee to assist another
19		commercial marine licensee who holds a valid, non-
20		lapsed aquarium permit with the taking of aquatic life
21		for commercial aquarium purposes.

21	freshwate	r nongame fish or other aquatic life.

- 1 "Lapsed" means an aquarium fish permit issued by the
- 2 department of land and natural resources that has not been
- 3 renewed prior to the expiration date of the permit or has not
- 4 been renewed for five or more years immediately preceding the
- 5 time of the transfer of the permit.
- 6 "Non-commercial aquarium purposes" means the taking of
- 7 marine life for aquarium purposes for recreation and not for
- 8 profit or gain nor as a means of livelihood."
- 9 SECTION 3. If any provision of this Act, or the
- 10 application thereof to any person or circumstance, is held
- 11 invalid, the invalidity does not affect other provisions or
- 12 applications of the Act that can be given effect without the
- 13 invalid provision or application, and to this end the provisions
- 14 of this Act are severable.
- 15 SECTION 4. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 5. This Act shall take effect on July 1, 2018;
- 18 provided that section 188-31(c), Hawaii Revised Statutes, under
- 19 section 2 of this Act shall take effect upon the date that the
- 20 injunction order as a result of Umberger v. Department of Land
- 21 and Natural Resources, 140 Hawaii 500, 403 P.3d 277 (2017), is

- 1 lifted, or the final disposition of Umberger v. Department of
- 2 Land and Natural Resources, whichever occurs earlier.

Aquarium Fish Permits; Commercial Marine License; Transfer or Renewal

Description:

Prohibits the department of land and natural resources from issuing new aquarium fish permits to take aquatic life for commercial or non-commercial aquarium purposes, except for a period of four months. Phases out the taking of aquatic life for commercial aquarium purposes by any method of catch, though allowing aquarium fish permits to be annually renewed by individuals possessing a commercial marine license and, for a period of five years, transferrable to another individual who possesses a commercial marine license. Continues to allow the taking of aquatic life for non-commercial aquarium purposes using certain nets or traps with an aquarium fish permit, and clarifies that non-commercial aquarium collecting by any method of catch is subject to a limit of five fish or aquatic life specimens per person, per day. Allows a commercial marine licensee to assist another commercial marine licensee who holds a valid, non-lapsed aquarium permit with the taking of aquatic life for commercial aquarium purposes. (SD1)

Report Title:

Teacher Home Assistance Program; Hawaii Housing Finance and Development Corporation; Appropriation

Description:

Establishes the teacher home assistance program to be administered by the Hawaii Housing Finance and Development Corporation to provide housing vouchers to full-time teachers employed by the department of education, including teachers at public charter schools, who teach in a hard-to-fill school, as determined by the department of education, and whose household income does not exceed eighty per cent of the area median income.
