A BILL FOR AN ACT

RELATING TO CLIMATE CHANGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that climate change is a
- 2 major threat to Hawaii. Act 32, Session Laws of Hawaii 2017,
- 3 states that, "not only is climate change real, but it is the
- 4 overriding challenge of the 21st century and . . . poses
- 5 immediate and long-term threats to the State's economy,
- 6 sustainability, security, and way of life". Article XI,
- 7 section 1 of the Hawaii State Constitution requires the State
- 8 and its political divisions to "conserve and protect Hawaii's
- 9 natural beauty and all natural resources" for future
- 10 generations. The Paris Climate Agreement states, "all Parties
- 11 are to undertake and communicate ambitious efforts".
- 12 The purpose of this Act is to require climate vulnerability
- 13 assessments for permit applications filed after January 1, 2020,
- 14 to construct, modify, relocate, or operate any regulated air
- 15 pollutant source, in order to further the State's commitment to
- 16 the goals of the Paris Climate Agreement.

| 16 | "Project" means any planned building, transportation, or |
| 17 | land use change by any public or private entity that may |
| 18 | generate significant greenhouse gas emissions in its |
| 19 | construction or operation phase." |
