# A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 286-2, Hawaii Revised Statutes, is
 amended by amending the definition of "motorcycle" to read as
 follows:

4 ""Motorcycle" means:

5 (1) Every motor vehicle that has a handlebar and seating
6 that requires the operator to straddle or sit astride
7 on it and has no seatbelt for the operator, and is
8 designed to travel on not more than three wheels in
9 contact with the ground, but excludes a farm tractor
10 and a moped; or

11 (2) Every motor vehicle [that has a steering wheel and
12 seating that does not require the operator to straddle
13 or sit astride on it, and is] with seatbelts designed
14 to travel on three wheels in contact with the ground,
15 called an autocycle which is certified by the
16 manufacturer to comply with all applicable Federal

1 Motor Vehicle Safety Standards as of the date of 2 manufacture." 3 SECTION 2. Section 286-71, Hawaii Revised Statutes, is 4 amended as follows: 5 1. By amending its title to read: 6 "[<del>[</del>] §286-71 Autocycles[<del>; registration; occupants;</del> 7 disclosure requirements].[]]" 8 2. By amending subsection (b) to read: 9 "(b) No person shall operate an autocycle on a public 10 street, road, or highway in this State unless the person 11 possesses a valid [type] category 3 driver's license pursuant to section [286-102(b)(2)] 286-102(b)(3) and the autocycle has been 12 13 duly registered pursuant to subsection (a)." 14 SECTION 3. Section 286-102, Hawaii Revised Statutes, is 15 amended by amending subsection (b) to read as follows: 16 "(b) A person operating the following category or 17 combination of categories of motor vehicles shall be examined as 18 provided in section 286-108 and duly licensed by the examiner of 19 drivers:
