A BILL FOR AN ACT

RELATING TO CEMETERIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Sunset Memorial Park
2 in Pearl City, Oahu, has been neglected for years and has been
3 the focal point of numerous complaints by people who have family
4 members buried there. The cemetery has been described as having
5 a damaged mausoleum; sinking graves; and broken, missing, or
6 obscured grave markers that are hidden by overgrown vegetation.

7 Since the death of its previous owner, Sunset Memorial Park
8 has had no registered owner on record. Volunteers have tried to
9 maintain the cemetery but have reluctantly stopped because of
10 state liability issues.

11 The dilapidated, unsightly state of Sunset Memorial Park is
12 of great concern for the families whose loved ones are buried
13 there and for the surrounding community. The park has fallen
14 into such disrepair that public safety and health are at issue.
15 A viable solution to this problem is long overdue.

16 Attempts to have the State add Sunset Memorial Park to its
17 list of four currently state-owned cemeteries in Aiea, Kapalama,



1 Alewa Heights, and Makiki are ongoing. The last time the State
2 took over a cemetery was in 1946.

3 It has been reported that the department of commerce and
4 consumer affairs is actively looking for a long-term solution
5 for Sunset Memorial Park and is considering all options.

6 The purpose of this Act is to:

- 7 (1) Limit liability for volunteers and nonprofit
8 organizations, nonprofit corporations, or other
9 entities that provide volunteers who maintain or
10 repair cemetery grounds; and
11 (2) Require the director of commerce and consumer affairs,
12 in consultation with the comptroller, to develop
13 strategies for the upkeep, repair, and maintenance of
14 Sunset Memorial Park.

15 SECTION 2. Chapter 662D, Hawaii Revised Statutes, is
16 amended by adding a new section to be appropriately designated
17 and to read as follows:

18 "§662D- Limited liability for volunteers maintaining or
19 repairing cemetery grounds. (a) A volunteer who maintains or
20 repairs cemetery grounds located in the State, including
21 cemeteries operated for profit pursuant to chapter 441, shall



1 not be liable to any person for injury or damage sustained as a
2 result of the actions of the volunteer to maintain or repair the
3 cemetery grounds, except for injury or damages resulting from
4 gross negligence or intentional misconduct.

5 (b) A nonprofit organization, nonprofit corporation, or
6 other entity that provides volunteers to maintain or repair
7 cemetery grounds located in the State, including cemeteries
8 operated for profit pursuant to chapter 441, shall not be liable
9 to any person for injury or damage sustained as a result of the
10 actions of a volunteer provided by the organization,
11 corporation, or entity to maintain or repair the cemetery
12 grounds, except for injury or damages resulting from gross
13 negligence or intentional misconduct.

14 (c) This section does not relieve any cemetery property
15 owner or cemetery authority from compliance with chapter 441.

16 (d) A volunteer providing services under this section for
17 a nonprofit organization, nonprofit corporation, or other entity
18 may only receive reimbursement for actual expenses incurred that
19 have been authorized for payment by the nonprofit organization,
20 nonprofit corporation, or other entity.



1 (e) Nothing in this section shall be construed to
2 authorize or permit the use of perpetual care funds for the
3 purposes of reimbursing costs incurred pursuant to this section.

4 (f) Notwithstanding any other law to the contrary, actions
5 of a volunteer in conformance with this section shall not
6 require licensure under chapter 441; provided that maintenance
7 and repair activities covered under this section shall be
8 limited to general maintenance, care, and preservation of
9 cemeteries, including keeping sod or grass in repair and caring
10 for trees and shrubs, but shall not include activities related
11 to burials.

12 (g) For purposes of this section, a volunteer may provide
13 maintenance and repair services as an individual and not as a
14 member or affiliate of a cemetery authority, nonprofit
15 corporation, nonprofit organization, or other entity, if the
16 volunteer:

17 (1) First obtains written approval from the cemetery owner
18 or cemetery authority, if one can be identified; and

19 (2) Does not receive compensation or reimbursement for any
20 expenses other than actual expenses incurred for
21 maintenance and repair of the cemetery."

1 SECTION 3. (a) The director of commerce and consumer
2 affairs, in consultation with the comptroller, shall develop
3 short-term and long-term strategies for the upkeep, repair, and
4 maintenance of Sunset Memorial Park in Pearl City, Oahu.

5 (b) The director of commerce and consumer affairs shall
6 report findings and recommendations related to activities
7 conducted pursuant to this section, including any proposed
8 legislation, to the legislature no later than twenty days prior
9 to the convening of the regular session of 2019.

10 SECTION 4. New statutory material is underscored.

11 SECTION 5. This Act shall take effect on July 1, 2018.

Report Title:

Sunset Memorial Park; Repairs; Maintenance; Cemetery; Department of Commerce and Consumer Affairs

Description:

Limits liability for volunteers and certain entities that provide volunteers to maintain or repair cemetery grounds. Requires the director of commerce and consumer affairs, in consultation with the comptroller, to develop strategies for repair and maintenance of Sunset Memorial Park in Pearl City, Oahu. Requires report to Legislature.
