# A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The county of Maui shall pursue available
- 2 remedies to recoup any and all moneys expended for the Front
- 3 Street Apartments affordable housing project from 3900
- 4 Corporation, leasehold fee owners of the applicable real
- 5 property, and Front Street Affordable Housing Partners Limited
- 6 Partnership, owners of the improvements constructed upon the
- 7 applicable real property, or their successors in interest in the
- 8 construction of the Front street apartments as an affordable
- 9 housing project.
- 10 SECTION 2. There is appropriated out of the Hawaii housing
- 11 finance and development corporation's rental assistance program
- 12 the sum of \$ or so much thereof as may be necessary for
- 13 fiscal year 2018-2019 for the Hawaii housing finance and
- 14 development corporation to maintain affordable rents to the
- 15 Front street apartments tenants by providing a three-year rent
- 16 subsidy; provided that:

1	(1)	no funds authorized pursuant to this section shall be

- 1 SECTION 3. There is appropriated out of the Hawaii housing
- 2 finance and development corporation revenues the sum of
- 3 \$ or so much thereof as may be necessary for fiscal year
- 4 2018-2019 to expedite and complete the construction of the
- 5 Leialii affordable housing project in Lahaina, Maui by 2021.
- 6 The sum appropriated shall be expended by the Hawaii
- 7 housing finance and development corporation for the purposes of
- 8 this Act; provided that the county of Maui expedites the
- 9 planning and permitting process for the Leialii affordable
- 10 housing project.
- 11 SECTION 4. This Act shall take effect upon its approval.

### Report Title:

Hawaii Housing Finance and Development Corporation; Affordable Housing; Maui; Front Street Apartments; Appropriation

### Description:

Requires the County of Maui to pursue remedies to recoup moneys expended for the Front Street Apartments affordable housing project from the owners. Appropriates moneys from the HHFDC rental assistance program as a rental subsidy for Front Street Apartments tenants, subject to matching dollar for dollar funds. Appropriates HHFDC revenues for the expedited construction of the Leialii affordable housing project, subject to the County of Maui expediting the permitting process. (SB2293 HD3)
