A BILL FOR AN ACT

RELATING TO VOTER REGISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
- 2 by adding a new section to part II to be appropriately
- 3 designated and to read as follows:
- 4 "\$11-A Applications for a civil identification card or
- 5 driver's license. (a) Notwithstanding any law to the contrary,
- 6 an affidavit on application for voter registration shall be a
- 7 part of the application associated with the issuance of a civil.
- 8 identification card under section 286-301 and a driver's license
- 9 under section 286-109.
- 10 (b) Applications for a civil identification card or
- 11 driver's license shall not be processed until the applicant has:
- 12 (1) Applied to register to vote; or
- 13 (2) Affirmatively declined to register to vote.
- (c) If an applicant for a civil identification card or
- 15 driver's license is already a registered voter, the application
- 16 shall serve to automatically update the applicant's voter
- 17 registration residence address, mailing address, or name, as may



be applicable. A notice to this effect shall be stated on any 1 2 application or change of address or name form utilized by the 3 examiner of drivers. (d) The examiner of drivers shall electronically transmit 4 5 to the office of elections, on a real time basis, the following information, as may be available, associated with each person 6 7 who does not affirmatively decline to register to vote: 8 (1) Name; 9 (2) Date of birth; 10 (3) Residence address; 11 (4) Mailing address; 12 (5) Digitized signature; 13 (6) Telephone number; 14 (7) Email address; 15 (8) Gender; 16 (9) Any address in another state that is associated with a 17 previous registration that the applicant authorizes to 18 be canceled; 19 (10) A notation that the applicant has attested that the 20 applicant meets all voter eligibility requirements, 21 including United States citizenship;

1	(11)	Whether the applicant chooses to become a permanent
2	:	absentee voter;
3	(12)	Whether the applicant was informed, if the applicant
4		is currently a registered voter, that the applicant's
5		name, residence address, and mailing address
6		associated with the applicant's voter registration
7		record will be updated to reflect what has been
8		provided in the application;
9	(13)	An electronic copy of the application in portable
10		document format; and
11	(14)	Other information specified by the chief election
12		officer.
13	(e)	Databases maintained or operated by the counties or
14	the depart	tment of transportation containing driver's license and
15	civil ide	ntification card information, including any documents
16	or images	, shall be electronically accessible by election
17	officials	and the statewide voter registration system to allow
18	for the t	imely processing of voter registration applications,
19	facilitate	e verification of information provided by online voter
20	registrat	ion applicants under section 11-15.3, ensure the

1 integrity of the voter registration rolls, or for any other 2 election purpose." 3 SECTION 2. Section 286-109, Hawaii Revised Statutes, is 4 amended to read as follows: 5 "\$286-109 General provision governing the issuance of 6 (a) Upon payment of the required fee and upon 7 demonstrating the ability to operate a certain category or categories of motor vehicles to the satisfaction of the examiner 8 9 of drivers, an applicant for a driver's license shall be issued 10 a single license of a design approved by the director of 11 transportation upon which is made a notation of: 12 (1) The category or categories of motor vehicles the 13 applicant may operate; 14 Any restrictive provisions to which the license is (2) 15 subject; 16 (3) Veteran status, if desired by the applicant; provided 17 that the notation shall be on the front of the license 18 and shall not include any designation other than the 19 term "veteran"; and 20 (4) When the license is issued to a person under twenty-21 one years of age, a statement, in clearly legible

1	print that shall contrast with the other information
2	appearing on the license, which indicates the date on
3	which the person will attain the age of twenty-one
4	years.
5	As used in this subsection, "veteran" means any person who
6	served in any of the uniformed services of the United States,
7	including veterans of the Korean conflict and persons who served
8	in the armed forces of the Republic of Korea, who fought under
9	the command of the United Nations led by the United States,
10	during the Korean conflict and are currently United States
11	citizens, and was discharged under conditions other than
12	dishonorable.

- (b) The examiner of drivers shall not issue or renew any driver's license using the driver's social security number on the driver's license.
- (c) Statutes of limitations and other provisions of this
 chapter notwithstanding, no driver's license or instruction
 permit shall be issued or renewed under this section, where the
 examiner of drivers is notified by the district judge, traffic
 violations bureaus of the district courts, or the judge of the
 circuit court that the applicant has failed to respond to a

- 1 traffic citation or summons, or failed to appear in court after
- 2 an arrest for the violation of any traffic laws of a county,
- 3 this chapter or chapter 286G, 287, 290, 291, or 291C, or of any
- 4 motor vehicle insurance laws under article 10C of chapter 431,
- 5 or of any motorcycle or motor scooter insurance laws under
- 6 article 10G of chapter 431, and the same remains delinquent and
- 7 outstanding, or the applicant, has as of the time of the
- 8 application, failed to comply in full with all orders of the
- 9 court; provided that the district court with whose order an
- 10 applicant has failed to comply in full, may approve the issuance
- 11 or renewal of a driver's license or instruction permit other
- 12 than a commercial driver's license upon conditions imposed by
- 13 the court for the satisfaction of the outstanding court order
- 14 and any other conditions as may be imposed by the court, if one
- 15 or more of the following conditions are met:
- 16 (1) The applicant is gainfully employed in a position that
- 17 requires driving and will be discharged if the
- applicant is unable to drive; or
- 19 (2) The applicant has no access to alternative
- transportation and therefore must drive to work;

- 1 provided further that if the applicant has failed to comply in
- 2 full with orders of the district court of more than one circuit,
- 3 the applicant shall obtain the approval of the district court of
- 4 each circuit in which the applicant has an outstanding court
- 5 order before a driver's license or instruction permit may be
- 6 issued or renewed under this subsection.
- 7 A driver's license or instruction permit issued or renewed
- 8 under this subsection shall be subject to immediate suspension
- 9 by the court upon the applicant's failure to remain in full
- 10 compliance with all conditions imposed by the court for the
- 11 issuance or renewal of the driver's license or instruction
- 12 permit. The examiner of drivers may place an indication of
- 13 restriction upon a driver's license or instruction permit issued
- 14 or renewed under this subsection. Proof of financial
- 15 responsibility under section 287-20 shall not apply to the
- 16 issuance or renewal of driver's licenses or instruction permits
- 17 under this subsection.
- 18 (d) An application for a driver's license from the
- 19 examiner of drivers shall include the information required under
- 20 section 11-A."



- 1 SECTION 3. Section 286-301, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+]\$286-301[+] Issuance of identification card or
- 4 temporary card. (a) To obtain an identification card from the
- 5 examiner of drivers, an individual shall complete an application
- 6 pursuant to section 286-303.
- 7 (b) The examiner of drivers, upon receipt of the
- 8 application by any individual who is a resident or a temporary
- 9 resident of this State, shall issue an identification card to
- 10 that individual upon receipt of any appropriate fee established
- 11 pursuant to section 286-309.
- 12 (c) The identification card shall be similar in size,
- 13 shape, and design to a driver's license, but shall not entitle
- 14 the individual to whom it is issued to operate a motor vehicle.
- 15 (d) The issuance of an identification card pursuant to
- 16 this section shall not place upon the State of Hawaii or any
- 17 agency any liability for the misuse or the acceptance of the
- 18 identification card as valid identification, which shall be left
- 19 entirely to the discretion of any individual to whom such card
- 20 is presented.

1 (e) An application for an identification card from the examiner of drivers shall include the information required under 2 3 section 11-A." SECTION 4. Section 286-311, Hawaii Revised Statutes, is 4 5 amended by amending subsection (a) to read as follows: "(a) [All] Except as required by sections 11-A, 286-109, and 286-301, information and records acquired by the examiner of 7 drivers under this part shall be confidential. All information 8 9 and records shall be maintained in an appropriate form and in an appropriate office in the custody and under the control of the 10 examiner. The information shall be available only to authorized 11 individuals under such restrictions as the director shall 12 prescribe. The examiner may dispose of any application or 13 14 identification card, or information or record relating to the 15 application or identification card, which does not include a 16 social security number, without regard to chapter 94, whenever, in the examiner's discretion, retention of the information or 17 record is no longer required or practicable." 18 19 SECTION 5. In codifying the new sections added by section 1 of this Act, the revisor of statutes shall substitute 20

Report Title:

Office of Elections Package; Voter Registration; Driver's License; Civil Identification Card

Description:

Requires an affidavit on application for voter registration to be included as part of the application for driver's licenses and civil identification cards. Prevents processing of application for driver's licenses or civil identification cards unless voter affidavit is complete or declined. Clarifies that applicant who does not want information electronically transmitted to office of elections must affirmatively decline to register to vote.
