A BILL FOR AN ACT

RELATING TO COMMUNITY PARAMEDIC SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a high percentage of
- 2 calls for emergency medical services are from repeat callers who
- 3 call multiple times per day for issues that do not require an
- 4 emergency response. Additionally, most 911 calls originate from
- 5 residences and are often for medical concerns that could be
- 6 addressed by a functioning community paramedic system. As the
- 7 call volume rises each year and the number of ambulance stations
- 8 remains the same, it is critical to establish community
- 9 paramedic services to provide appropriate services to non-
- 10 emergency callers who would otherwise be using valuable
- 11 emergency medical services needed by other individuals.
- 12 Focused on identifying solutions, the department of health
- 13 emergency medical services and injury prevention system branch
- 14 convened a working group and compiled a report prior to the 2017
- 15 legislative session in response to House Concurrent Resolution
- 16 No. 90, Regular Session of 2016. The working group, in its
- 17 December 2016 report to the legislature, recommended that a

- 1 community paramedic pilot program be established at two to three
- 2 of the six metropolitan and rural sites it identified. The
- 3 working group found that community paramedicine could reduce the
- 4 high volume of 911 calls for non-emergency medical conditions.
- 5 It also found that community paramedicine could improve health
- 6 in the State by addressing the following: callers needing
- 7 alternate destinations other than emergency departments; post-
- 8 hospital discharge care; the homeless population; hospice care;
- 9 behavioral health; and acute and chronic medical conditions such
- 10 as infectious diseases, diabetes, hypertension, and asthma.
- 11 The purpose of this Act is to implement the recommendations
- 12 of the working group convened pursuant to House Concurrent
- 13 Resolution No. 90, Regular Session of 2016, by establishing and
- 14 appropriating funds for a three-year community paramedic
- 15 services pilot program and requiring an evaluation of the pilot
- 16 program's effectiveness.
- 17 SECTION 2. There is established a three-year community
- 18 paramedic services pilot program, to be administered by the
- 19 department of health. The pilot program shall commence on
- 20 January 1, 2019, and shall terminate on December 31, 2021. The
- 21 program shall be conducted at two pilot sites approved by the

1	director	of health, with at least one site on a heighbor island.
2	The progr	am shall include the following components:
3	(1)	Training and certification. Kapiolani community
4		college shall:
5		(A) Develop a community paramedic curriculum in
6		consultation with the department of health;
7		(B) Institute a community paramedic training program;
8		and
9		(C) In partnership with the University of Hawaii
10		community colleges, train community health
11		workers based on common core competencies to work
12		with community paramedics;
13	(2)	Staffing. The department of health shall recruit and
14		hire a community paramedicine administrator, an
15		appropriate number of community paramedicine medical
16		directors for each pilot site, and other personnel as
17		needed;
18	(3)	Equipment and supplies. The department of health
19		shall procure non-transport vehicles and contract with
20		emergency medical services providers to provide
21		necessary supplies and medical equipment;

1	(4)	Medical records. Community paramedics providing
2		services under the pilot program shall initially use
3		the existing Hawaii emergency medical services medical
4		record system but shall transition to a more suitable
5		medical record system when funds become available and
6		such a system is identified; and
7	(5)	Billing. The department of health shall develop a fee
8		schedule for community paramedic services in
9		consultation with insurance carriers. Billing and
10		collections for community paramedic services shall be
11		conducted by the department of health emergency
12		medical services and injury prevention system branch.
13		All moneys collected shall be deposited into the
14		general fund of the State.
15	SECT	ION 3. The department of health emergency medical
16	services	and injury prevention system branch shall submit a
1 7	report on	the status of the implementation of the community

resources and legislation required, to the legislature no later

than twenty days prior to the convening of the regular session

2	services	and i	njury prevention system branch shall submit a			
3	report on	the :	results of the three-year community paramedic			
4	services	pilot	program, including any proposed legislation, to			
5	the legis	latur	e no later than twenty days prior to the convening			
6	of the regular sessions of 2020, 2021, and 2022. The report					
7	shall address but not be limited to the following:					
8	(1)	An e	valuation of the effectiveness of the pilot			
9		prog	ram at the selected sites in terms of patient			
10		outc	omes, 911 system impact, and costs within eighteen			
11		mont]	ns of the start of services at the pilot sites;			
12	(2)	A ca	lculation of the program's return on investment			
13		base	d on:			
14		(A)	The estimated cost savings from any reduction in			
15			usage of emergency ambulance services, emergency			
16			facilities, and associated personnel as a direct			
17			result of the provision of community paramedic			
18			services during the three-year pilot program; and			
19		(B)	The overall impact of the pilot program.			

1	(3) Workforce issues, including but not limited to
2	recruitment, access to training, certification, and
3	retention efforts; and
4	(4) Sustainability and expansion efforts, including
5	funding, staffing needs, and fee schedule.
6	SECTION 5. No later than June 30, 2019, the department of
7	health shall adopt interim rules, which shall be exempt from
8	chapters 91 and 201M, Hawaii Revised Statutes, to effectuate the
9	purposes of this Act; provided that the interim rules shall
10	remain in effect until , , or until the department
11	adopts rules pursuant to chapter 91, Hawaii Revised Statutes,
12	whichever occurs sooner.
13	SECTION 6. There is appropriated out of the general
14	revenues of the State of Hawaii the sum of \$1,500,000 or so much
15	thereof as may be necessary for fiscal year 2018-2019 to the
16	department of health for program development, site operation,
17	administration, and evaluation for the community paramedic
18	services pilot program established pursuant to this Act.
19	The sum appropriated shall be expended by the department of
20	health for the purposes of this Act.

1	SECTION	7.	There	is	appropriated	out	of	the	general

- 12 December 31, 2021.
