A BILL FOR AN ACT

RELATING TO BIOFUELS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State has the 2 goal of achieving one hundred per cent clean energy by the year 3 2045. However, currently Hawaii is the most fossil fuel 4 dependent state in the nation. Hawaii's dependence on fossil 5 fuel can best be explained in large part by the State's economic 6 dependence on tourism and the military, as well as the reliance 7 on the shipping industry to deliver consumer goods and 8 industrial materials. Reducing Hawaii's reliance on fossil 9 fuels and generating one hundred per cent of the State's energy 10 from renewable resources will help Hawaii's economy by keeping an estimated \$3,000,000,000 in the State that would otherwise be 11 12 spent on imported oil.

13 The legislature further finds that biofuels could
14 significantly advance the State's clean energy goals. Biofuels
15 use organic matter to produce a predictable supply of green
16 energy that can be stored in presently used power plants.
17 Additionally, biofuels can be locally produced, directly

	creating job growth in the energy and farming industries. In

1 (b) Based on the department of agriculture's assessment of 2 the advanced biofuels pilot project, the department shall 3 determine whether to continue, expand, or end the pilot project. 4 (C) The department of agriculture shall submit a report of its findings and recommendations, including any proposed 5 6 legislation, to the legislature no later than twenty days prior 7 to the convening of the regular session of 2019. 8 SECTION 3. There is appropriated out of the general 9 revenues of the State of Hawaii the sum of \$ or so

10 much thereof as may be necessary for fiscal year 2017-2018 and 11 the same sum or so much thereof as may be necessary for fiscal 12 year 2018-2019 for the establishment and implementation of the 13 two-year advanced biofuels pilot project.

14 The sums appropriated shall be expended by the department15 of agriculture for the purposes of this Act.

16 SECTION 4. This Act shall take effect on July 1, 2017.
