### A BILL FOR AN ACT

RELATING TO CARGO INSPECTIONS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that over ninety per cent 2 of the more than two hundred thousand shipping cargo containers 3 that arrive in Hawaii each year are from the continental United 4 States. Only a small fraction of these containers, however, are 5 inspected by government agencies. Shipping companies conduct 6 random checks of less than five per cent of incoming cargo 7 containers, and these inspections are mainly conducted to ensure 8 that senders of cargo have been properly charged. The lack of 9 sufficient cargo inspections means that there is ample 10 opportunity for illegal fireworks and explosives to be smuggled 11 into the State.

12 The legislature further finds that increased inspections 13 need to be carefully crafted to avoid delays and inefficiencies 14 in harbor operations that could impede commerce. One approach 15 is to use dogs to inspect cargo after arrival at the harbors but 16 prior to pick-up.

1	The purpose of this Act is to increase random inspections
2	of incoming cargo for illegal fireworks and explosives by
3	establishing a pilot program using dogs to inspect cargo
4	shipments after arrival at the harbors.
5	SECTION 2. (a) The departments of defense and
6	transportation, in consultation with federal and state agencies
7	and private organizations involved with shipping cargo into the
8	State, may develop and implement a three-year pilot program to
9	use dogs to inspect incoming cargo for illegal fireworks and
10	explosives smuggled into the State. The program, if
11	implemented, shall begin no later than January 31, 2019.
12	(b) Any pilot program under subsection (a) shall include
13	the use of dogs to inspect incoming cargo that, after arrival
14	into the State, is to be transported from any harbor to off-site
15	facilities that include:
16	(1) Freight forwarder warehouses and other facilities
17	where consolidated cargo transported from any state
18	harbor to the final destination is segregated and
19	prepared for delivery; and
20	(2) Other commercial facilities where cargo containers
21	transported from any state harbor are unloaded.

1 SECTION 3. If a pilot program is implemented pursuant to 2 this Act, no later than twenty days prior to the convening of the 2020 regular session, the department of transportation shall 3 4 submit to the legislature a report on the implementation of the 5 pilot program established pursuant to this Act. The report 6 shall include findings and recommendations, including costs 7 expended to date, the estimated cost of operating the program on 8 a permanent basis, and any proposed legislation. 9 SECTION 4. There is appropriated out of the federal funds 10 received under the homeland security grant program the sum of 11 \$ or so much thereof as may be necessary for fiscal 12 year 2018-2019 to establish and administer a pilot program 13 authorized by this Act. 14 The sum appropriated shall be expended by the department of
