A BILL FOR AN ACT

RELATING TO DENTAL LICENSURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the current law
2 requiring passage of the American Board of Dental Examiners
3 (ADEX) examination for licensure as a dentist in the State was
4 originally enacted to allow Hawaii to participate in a
5 standardized national examination process. The first ADEX
6 dental examination was administered in Hawaii in December 2005.
7 However, since that time, limiting the approved examination to
8 only the ADEX examination has created many difficulties for
9 dentists seeking to obtain licensure in Hawaii. For example,
10 experienced, qualified, and competent dentists who have been
11 practicing licensed dentistry in other states prior to 2005 and
12 who desire to relocate and practice dentistry in Hawaii have
13 been unable to do so because they did not take and pass the ADEX
14 examination.

15 Permitting successful passage of other nationally
16 recognized clinical dental examinations recommended by the
17 American Dental Association or meeting certain professional



1 qualifications as part of the licensure process will allow more
2 dentists, whose professional competency has been clearly
3 demonstrated in other states, to practice within the State,
4 thereby increasing access to dental services for Hawaii
5 residents.

6 The purpose of this Act is to increase access to high-
7 quality dental care in the State by allowing the board of dental
8 examiners to accept other nationally recognized clinical dental
9 examinations recommended by the American Dental Association or
10 certain professional qualifications to meet licensure
11 requirements.

12 SECTION 2. Section 448-9.4, Hawaii Revised Statutes, is
13 amended to read as follows:

14 "§448-9.4 ~~[American Board of Dental Examiners (ADEX)-~~
15 ~~examination; regional examinations.] Dental licensure~~
16 ~~examination; other licensing qualifications.~~ An applicant shall
17 [take] :

18 (1) Take and pass the ADEX examination[, ~~and neither the~~
19 ~~state examination nor any regional examination shall~~
20 ~~be accepted.] or any other nationally recognized~~



1 clinical dental examination recommended by the
2 American Dental Association; or

3 (2) Be a practicing dentist who:

4 (A) Graduated from an accredited school of dentistry;

5 (B) Holds a license to practice dentistry in another
6 state whose licensing requirements include

7 passage of the ADEX examination, its predecessor
8 examination, or another nationally recognized,

9 substantially equivalent examination recommended
10 by the American Dental Association;

11 (C) Is in good standing in the state of licensure;
12 and

13 (D) Has a least five years of experience in the
14 practice of dentistry."

15 SECTION 3. Statutory material to be repealed is bracketed
16 and stricken. New statutory material is underscored.

17 SECTION 4. This Act shall take effect on July 1, 2018.


