A BILL FOR AN ACT

RELATING TO CESSPOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 . SECTION 1. The legislature finds that public health and
- 2 the quality of Hawaii's drinking water, streams, ground waters,
- 3 and ocean are being harmed by water pollution from cesspools.
- 4 Hawaii has eighty-eight thousand cesspools that deposit
- 5 approximately fifty-three million gallons of raw sewage directly
- 6 into the groundwater every day. Drinking water, public
- 7 recreation, and the precious coral reefs, on which Hawaii's
- 8 economy, shoreline, recreation, fisheries, and native species
- 9 depend, are or may be harmed by such pollution.
- 10 The purpose of this Act is to establish a cesspool upgrade
- 11 task force to consider and recommend means by which the
- 12 department of health can ensure that cesspools on properties
- 13 that are within priority upgrade areas are converted to more
- 14 environmentally-responsible waste treatment systems or connected
- 15 to sewer systems within fifteen years.

1	SECTION 2. (a) The cesspool upgrade task force is	
2	establish	ed within the department of health for administrative
3	purposes.	The task force shall have the following objectives:
4	(1)	Protect public health and preserve the quality of
5		Hawaii's drinking water, streams, ground waters, and
6		ocean while taking into consideration the very large
7		number of pre-existing cesspools in the State;
8	(2)	Consider and recommend means by which the department
9		of health can ensure that cesspools on properties that
10		are within priority upgrade areas are converted to
11		more environmentally-responsible waste treatment
12		systems or connected to sewer systems within fifteen
13		years;
14	(3)	Develop definitions and criteria for priority upgrade
15		areas and acceptable waste treatment systems or
16		connections; and
17	(4)	Identify physical, practical, and financial
18		impediments that may be encountered by land owners who
19		are required to connect pre-existing cesspools to a
20		sewer system or convert cesspools to an individual

1		waste treatment system and recommend solutions to
2		those impediments.
3	(b)	The cesspool upgrade task force shall consist of the
4	following:	
5	(1)	The director of health or the director's designee, who
6		shall serve as chairperson;
7	(2)	The mayors of each county or their respective
8		designees;
9	(3)	A member appointed by the Hawaii Association of
10		REALTORS;
11	(4)	A member appointed by the Sierra Club of Hawaii;
12	(5)	A member appointed by the Hawaii Reef and Ocean
13		Coalition;
14	(6)	One member appointed by the speaker of the house of
15		representatives; and
16	(7)	One member appointed by the president of the senate.
17	Task force members may recommend additional members with	
18	appropria	te specialized expertise to the task force, for
19	approval	by the chairperson.
20	(c)	Members of the task force shall serve without
21	compensat	ion, but shall be reimbursed for reasonable expenses

- 1 incurred, including travel expenses. No member of the task
- 2 force shall be made subject to chapter 84, Hawaii Revised
- 3 Statutes, solely because of that members' participation as a
- 4 member of the task force.
- 5 (d) The task force shall submit a report of its findings
- 6 and recommendations, including proposed legislation, to the
- 7 legislature no later than twenty days prior to the convening of
- 8 the regular session of 2019.
- 9 (e) The department of health shall provide administrative
- 10 and clerical support required by the task force.
- 11 (f) The task force shall be dissolved on June 30, 2019.
- 12 SECTION 3. This Act shall take effect on December 31,
- **13** 2050.
