A BILL FOR AN ACT

RELATING TO PSYCHOLOGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1

PART I

SECTION 1. The legislature finds that properly licensed school psychologists provide effective services to help children and youth succeed academically, socially, behaviorally, and emotionally by providing direct educational and mental health services for children and youth, as well as working with parents, educators, and other professionals to create supportive learning and social environments for all children.

9 Currently, Hawaii is the only state without certification 10 or licensure for school psychologists. Without orderly licensing, the State cannot ensure that functioning school 11 12 psychologists are properly qualified and delivering appropriate 13 services. In addition, the State's failure to properly license 14 school psychologists means that by law the State is unable to 15 seek warranted reimbursements from the federal medicaid program 16 for the use of school psychologists in an educational setting. 17 Consequently, it is necessary to establish a licensure program

to ensure the employment of qualified school psychologists and
 to allow schools utilizing school psychologists to properly seek
 available federal medicaid funds.

4 The legislature further finds that a proper licensing 5 program requires establishing meaningful criteria and guidelines 6 for the licensure of school psychologists. The National 7 Association of School Psychologists' Standards for the 8 Credentialing of School Psychologists provides a model upon 9 which these guidelines may in part be based. The National 10 Association of School Psychologists' Standards create a set of 11 national standards that can serve to regulate the credentialing 12 of school psychologists. School psychologists who hold a 13 National Association of School Psychologists credential have met 14 these national standards.

15 The legislature finds that accredited school psychologists 16 should be licensed by and registered with the board of 17 psychology to ensure the delivery of quality service to students 18 and the community. The legislature additionally finds that 19 school psychologists and the practice of school psychology 20 should be subject to regulation and control to protect the 21 public from the unqualified practice of school psychology and

from unprofessional conduct by persons licensed to practice
 school psychology.

Accordingly, the purpose of this Act is to establish the
recommended criteria for the licensure of school psychologists,
including graduate coursework, practica, and internship
requirements based in part on the National Association of School
Psychologists' Standards.

8 SECTION 2. Chapter 465, Hawaii Revised Statutes, is
9 amended by adding a new part to be appropriately designated and
10 to read as follows:

11 "PART . SCHOOL PSYCHOLOGISTS

12 \$465-Findings and declaration of necessity. It is the 13 intent of the legislature to establish standards for the 14 licensing of school psychologists to address the present and 15 critical need for ensuring that those individuals requiring the 16 services of a licensed school psychologist receive appropriate 17 services by highly qualified and licensed professionals. The 18 special state interest for creating this part is recognized, notwithstanding the requirements of section 26H-6. 19 20 §465-Definitions. As used in this part:

"Accredited educational institution" means a university or 1 2 college accredited by the Western Association of Schools and 3 Colleges or a comparable regional body. 4 "Approved private school" means any educational institution 5 that is licensed or accredited by the Hawaii Association of 6 Independent Schools. 7 "Board" means the board of psychology. "Developmental center" means any facility that offers 8 9 developmentally appropriate psychological, educational, social, 10 adaptive, language, or motor skills training or 11 psychoeducational and multidisciplinary diagnostic services to 12 special needs children or developmentally disabled adults. 13 "Practice of school psychology" means the application of 14 principles, methods, and procedures of measurement, prediction, 15 evaluation, testing, counseling, consultation, and instruction 16 related to and consistent with the national standards 17 articulated by the most current Model for Comprehensive and 18 Integrated School Psychological Services, as published by the 19 National Association of School Psychologists or its successor, 20 in a school setting. "Practice of school psychology" does not 21 include private practice.

1 §465-Fees; disposition. (a) Upon application for a 2 new license and at each biennial renewal, each applicant shall 3 pay a license fee of \$ and a compliance resolution 4 fund fee of \$. Application fees paid pursuant to this 5 part shall not be refundable. Fees collected pursuant to this 6 section shall be deposited into the compliance resolution fund 7 established pursuant to section 26-9(0).

8 (b) Every school psychologist holding a license under this 9 part shall renew the license with the board no later than June 10 30 of each even-numbered year. Every school psychologist shall 11 pay a renewal fee and comply with the continuing education 12 requirements provided in rules adopted by the board.

13 (c) A school psychologist shall meet the continuing 14 education requirements by obtaining eighteen credit hours 15 accredited by the Association as provided in the board's 16 rules. To determine compliance, the board may conduct a random 17 audit. A school psychologist selected for audit shall be 18 notified by the board. Within sixty days of notification, the 19 school psychologist shall provide to the board documentation to 20 verify compliance with the continuing education requirements.

(d) Failure to renew, pay the renewal fee, and, in the
 case of audited school psychologists, provide documentation of
 compliance shall constitute a forfeiture of license, which may
 be restored only upon the submission of written application
 therefor, payment to the board of a restoration fee, and, in the
 case of audited school psychologists, documentation of
 compliance.

8 **Description of services.** (a) A person practices §465-9 as a school psychologist if the person delivers services to 10 children and students from birth through college who are 11 eligible to be enrolled in educational and intermediate 12 educational units, special education programs, universities and 13 colleges, early intervention programs, developmental centers, 14 and approved private schools. School psychologists are limited 15 to practicing within these settings, and licensure does not 16 allow for private practice.

(b) Services delivered pursuant to this section are articulated under the domains of the National Association for School Psychologists' Model for Comprehensive and Integrated School Psychological Services, as may be amended, which represents the National Association of School Psychologists'

official policy regarding the delivery of school psychological
 services and the ethical standards developed and published by
 the National Association of School Psychologists.

4 §465-Practice of school psychology; license required. 5 Beginning on July 1, 2021, no person shall engage in the (a) 6 practice of school psychology or represent, announce, or 7 advertise oneself, publicly or privately, as a "licensed school psychologist" or "school psychologist" or affix any other words, 8 9 letters, abbreviations, or insignia to the person's name 10 indicating or implying that the person is engaged in the 11 practice of school psychology, without having first obtained a 12 license as provided in this part.

(b) A person who is a student in an accredited school psychology program may use a title of "school psychology intern" or "school psychology practicum student" that indicates the person's training status; provided that the person shall not identify the person's self as a "licensed school psychologist" or "school psychologist" or imply that the person is licensed to practice school psychology.

20 (c) Any person who violates this section shall be subject21 to a fine of no more than \$1,000 for each separate offense.

- 14 (13)Failing to report to the board, in writing, any 15 disciplinary decision issued against the licensee or 16 the applicant in another jurisdiction within thirty 17 days after the disciplinary decision is issued; 18 (14)Employing, utilizing, or attempting to employ or utilize at any time any person not licensed under this 19 20 chapter where licensure is required; or

(15) Violating this part, chapter 436B, or any rule or

3 (b) Any licensee or applicant who violates this section
4 may also be fined no less than \$100 and no more than \$1,000.

5 §465-**Exemption.** This part is not intended to restrict 6 the practice of other licensed or credentialed practitioners 7 practicing within their own recognized scopes of practice in 8 educational settings. This part shall not apply to any person 9 working within the scope of practice or duties of another 10 licensed profession that overlaps with the practice of school 11 psychology; provided that the person does not use the title 12 "school psychologist" or "licensed school psychologist"."

13 SECTION 3. Chapter 465, Hawaii Revised Statutes, is 14 amended by designating sections 465-1 to 465-15 as part I and 15 inserting a title before section 465-1 to read as follows:
