board members shall serve not more than three consecutive threeyear terms. Teacher and educational officer members who retire
during a term may serve the remainder of their current term."



SECTION 2. Section 302A-805, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "§302A-805 Teachers; license or permit required; renewals. 4 [Beginning July 1, 2002, all new licenses shall be issued by the 5 board.] No person shall serve as a half-time or full-time 6 teacher in a public school without first having obtained a 7 license or permit from the board under this subpart. All 8 licenses and permits issued by the board shall be valid only for 9 the fields specified on the licenses and permits and shall be 10 renewable every five years for a standard license and every ten 11 years for an advanced license if the individual continues to: 12 (1) Satisfy the board's licensing and permit standards and 13 submits verification, in a form specified by the 14 board, that the individual has completed activities 15 specified by the board in fulfillment of each of the 16 teacher performance standards established by the 17 board; 18 (2) Show evidence of successful teaching in the previous 19 five years through verification by a supervisor, in a 20 form specified by the board;

1 Meet the professional fitness requirements established (3) 2 by the board; Satisfy the board's requirements for renewal of 3 (4) 4 licenses [+] and permits; and (5) 5 Pay all applicable license and permit fees in a timely 6 manner. 7 The board shall randomly audit a licensee's or permit holder's 8 compliance with paragraph (1) and may establish rules, pursuant 9 to chapter 91, for the random audits. 10 No person shall be issued a license or permit or teach on an emergency basis in the public schools without having first 11 12 paid the fees established by the board in accordance with 13 chapter 91. 14 The failure to timely renew a license $[\tau]$ or permit, pay all 15 fees in a timely manner, or comply with any other requirement 16 provided by law or administrative rule shall result in the automatic forfeiture of the license [-] or permit.
