## A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF PUBLIC SAFETY.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Act 49, section 3, Session Laws of Hawaii 2017,
- 5 appropriated \$3,344,801 in general funds to the department of
- 6 public safety to pay for temporary, non-state housing for two
- 7 hundred forty-eight Halawa correctional facility inmates during
- 8 a capital improvement construction project at the facility
- 9 pursuant to department of accounting and general services job
- 10 number 12-27-5644, security electronics and hardware repairs and
- 11 improvements, through December 2017. The project's timeline has
- 12 been delayed due to a specialty subcontractor's inability to
- 13 perform the job, requiring the hiring of a new, qualified vendor
- 14 and postponing completion of the project to October 2018.
- 15 Moneys are necessary to continue temporarily housing the two
- 16 hundred forty-eight inmates at a non-state facility for an



- 1 additional six months to enable the project to move forward to
- 2 completion.
- The purpose of this Act is to make an emergency
- 4 appropriation to provide moneys for the department of public
- 5 safety to temporarily house the two hundred forty-eight inmates
- 6 at a non-state facility for an additional six months, in order
- 7 for work on department of accounting and general services job
- 8 number 12-27-5644, security electronics and hardware repairs and
- 9 improvements, to move forward to completion.
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so much
- 12 thereof as may be necessary for fiscal year 2017-2018 for the
- 13 department of public safety to temporarily house two hundred
- 14 forty-eight inmates at a non-state facility for an additional
- 15 six months during completion of a capital improvement project at
- 16 the Halawa Correctional Facility pursuant to department of
- 17 accounting and general services job number 12-27-5644, security
- 18 electronics and hardware repairs and improvements.

- 1 The sum appropriated shall be expended by the department of
- 2 public safety for the purposes of this Act.
- 3 SECTION 4. This Act shall take effect on July 1, 2050.
