# A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of education is one of the largest departments in the State, with 2 3 two hundred fifty-six schools and forty-two thousand full-time 4 and part-time employees. In addition to the superintendent of 5 education, there is one deputy superintendent, one senior 6 assistant superintendent, and four assistant superintendents. 7 One assistant superintendent, the assistant superintendent for 8 information technology services, oversees six branches and 9 directs a central and field staff of approximately one hundred 10 eighty employees.

Although the department of education is part of the state executive branch, unlike other executive branch departments, it continues to completely handle its own information technology services, including operating its own broadband network, internet services, help desk, e-mail systems, and data center and independently undertaking information technology budget preparation and execution. While large departments like the

1 department of education may always need to have its own information technology staff for certain functions, especially 2 3 where intimate knowledge of the educational functions and 4 processes of the department is essential, there may be 5 significant benefits to working collaboratively within the 6 executive branch and more closely with other departments and the 7 office of enterprise technology services. 8 The purpose of this Act is to require the office of

9 enterprise technology services, in collaboration with the 10 department of education, to establish a working group to study 11 the department of education's information technology 12 infrastructure, operations, and services.

13 SECTION 2. (a) The office of enterprise technology 14 services, in collaboration with the department of education, 15 shall convene a working group to evaluate the department of 16 education's information technology infrastructure, operations, 17 and services, including but not limited to:

18 (1) Identifying and reviewing duplicative, overlapping, or
19 common services and infrastructure provided by the
20 department of education and office of enterprise
21 technology services;
