RELATING TO HIGHWAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291C-131, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "§291C-131 Spilling loads on highways; penalties. (a) No 4 vehicle shall be moved on any highway, unless the vehicle is so 5 constructed, covered, or loaded as to prevent any of its load other than clear water or feathers from live birds from 6 7 dropping, sifting, leaking, blowing, spilling, or otherwise 8 escaping therefrom, except that sand may be dropped for the 9 purpose of securing traction, or water or other substance may be 10 sprinkled on a highway in cleaning or maintaining the highway.

(b) No vehicle shall be driven or moved on any highway when any load thereon is not entirely within the body of the vehicle; provided that this prohibition shall not apply if the load is securely fastened by means of clamps, ropes, straps, cargo nets, or other suitable mechanical device to prevent such load from dropping onto the highway or from shifting in any manner and, further, no vehicle shall be operated on any highway



with any load thereon projecting beyond the extreme width of the
 vehicle.

3 (c) Vehicles carrying agricultural produce from fields
4 during harvesting shall be exempt from the requirements of this
5 section but the owner of the vehicle must provide for the
6 reasonable removal of all such produce spilled or dropped on the
7 highway.

8 (d) No vehicle shall be driven or moved on any highway
9 with any load if the load is not entirely covered by a cargo
10 net, tarpaulin, canopy, or other material designed to cover the
11 load to prevent the load from escaping from the vehicle, where
12 the load consists partially or entirely of loose paper, loose
13 rubbish, plastics, empty cartons, dirt, sand, or gravel.

(e) Vehicles transporting a granular load consisting of dirt, sand, or gravel on any highway shall not be required to cover their granular load if the granular load does not extend, at its peak, above any point on a horizontal plane equal in height to the top of the side, front, or rear part of the cargo container area that is the least in height.

20 (f) No vehicle shall be driven or moved on any highway21 with a load consisting of rocks, stones, or boulders if the

load, at its peak, extends above any point on a horizontal plane 1 equal in height to the top of the side, front, or rear part of 2 the cargo container area that is the least in height. 3 4 (g) Vehicles transporting asphalt or other loads that are of a temperature that would melt or otherwise damage a tarp or 5 other covering shall be exempt from the requirement that the 6 7 load be covered. [-(g)] (h) Violation of this section shall be considered an 8 offense as defined in section 701-107(5), shall not be subject 9 to the provisions of chapter 291D, and shall subject the owner 10 or driver of the vehicle, or both, to the following penalties 11 without possibility of probation or suspension of sentence: 12 13 (1) For a first violation, by a fine of not less than \$250 and not more than \$500. 14 (2) For a second violation involving a vehicle or driver 15 16 previously cited under this section within one year: 17 Suspension of the vehicle registration or (A) suspension of the license of the driver, or both, 18 for not less than five working days but not more 19 20 than ten working days; and
