1	SECT	TION 1. Chapter 346, Hawaii Revised Statutes, is
2	amended b	by adding a new section to subpart A of part VIII to be
3	appropria	tely designated and to read as follows:

5	oversight	committee. (a) There is created within the
6	departmen	t's benefit, employment and support services division
7	the child	care facility inspection information oversight
8	committee	. The purpose of the oversight committee shall be to
9	oversee i	mplementation and compliance with the requirements of
10	section 3	46-153(c).
11	The	oversight committee shall be composed of:
12	(1)	The director or director's designee, who shall serve
13		as chair of the committee;
14	(2)	The coordinator of the state advisory council on early
15		childhood education and care, or the coordinator's
16		designee;
17	(3)	One representative from each of the department's
18	•	statewide child care licensing units;

1	(4)	The quality rating and improvement system
2		administrator of the University of Hawaii's center on
3		the family;
4	(5)	A member of the senate appointed by the president of
5		the senate;
6	(6)	A member of the house of representatives appointed by
7		the speaker of the house of representatives;
8	(7)	A registered family child care home provider, to be
9		appointed by the director;
10	(8)	A licensed group child care center provider, to be
11		appointed by the director;
12	<u>(9)</u>	A licensed group child care home provider, to be
13		appointed by the director; and
14	(10)	One parent representative of child care consumers from
15		each of the geographic areas served by the statewide
16		child care licensing units, to be appointed by the
17		respective supervisors of each unit.
18	(b)	Members of the oversight committee shall be appointed
19	without r	egard to section 26-34. Each appointed member shall
20	serve no	more than two consecutive four-year terms, not to
21	exceed ei	ght consecutive years; provided that ex officio members

- 1 shall serve for the length of their respective terms of office.
- 2 Any appointed member of the oversight committee whose term is
- 3 expired and is not disqualified from membership pursuant to this
- 4 subsection may continue in office as a holdover member until a
- 5 successor member is appointed. Any vacancy shall be filled for
- 6 the unexpired term pursuant to this section. The director may
- 7 suspend or remove for cause any member of the oversight
- 8 committee after due notice and public hearing. The members of
- 9 the oversight committee shall serve without compensation but may
- 10 be reimbursed for expenses, including travel expenses, incurred
- 11 in the course of performance of official duties. Members of the

- 13 SECTION 2. Section 346-153, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "§346-153 Records of [deficiencies and complaints;]
- 16 inspections; release to public. (a) For every child care
- 17 facility, the department shall maintain records for the current
- 18 and previous two years of: results of its inspections;
- 19 notifications to providers of deficiencies; corrective action
- 20 taken; complaints of violations of rules adopted under this
- 21 part; results of its investigations; resolution of complaints;

and suspensions, revocations, reinstatements, restorations, and 2 reissuances of licenses, temporary permits, and registrations 3 issued under this part. 4 (b) Notwithstanding any other law to the contrary, the 5 records described in [this section] subsection (a) shall be 6 available for inspection in the manner set forth in chapter 92F 7 and may be posted by the department on a public website [+] in 8 accordance with this section; provided that with respect to 9 records of family child care homes and group child care homes, 10 sensitive personal information, including home addresses, or 11 information provided to the department with the understanding 12 that it would not be publicly divulged shall be deleted or 13 obliterated prior to making the records available to the public. 14 Nothing in this section shall authorize the department to 15 release the names of or any other identifying information on 16 complainants. The department may withhold information on a 17 complaint for which an investigation is being conducted for not 18 more than ten working days following the date of filing of the 19 complaint; provided that if an investigation relates to an 20 alleged criminal offense, no information shall be released until 21 the investigation has been completed and the director has

3	<u>(c)</u>	Beginning with inspections occurring on January 1,
4	2018, the	department shall post on its website electronic copies
5	of report	s for all inspections it performs of child care
6	<u>facilitie</u>	s subject to this part. Except as provided in
7	subsection	n (b), each report shall be posted on the department's
8	website w	ithin thirty working days of the conclusion of each
9	inspectio	n and shall include:
10	(1)	The date of the inspection;
11	(2)	A description of violations of relevant state laws or
12		rules, if applicable;
13	<u>(3)</u>	Plans of correction and the status of corrective
14		actions in response to any violations, if applicable;
15	(4)	A list and description of all corrective actions taken
16		by the child care facility, if applicable, to be
17		submitted by the facility and added to the report at a
18		later time, as determined by the department; and
19	<u>(5)</u>	Other information regarding the quality and condition
20		of the child care facility as the department deems
21		appropriate.

1 (d) The department shall submit an annual report to the 2 legislature on all records and actions subject to this section. 3 For all actions that involve a complaint of a suspected 4 violation or an actual violation discovered by the department, 5 the report shall include the department's findings regarding the 6 suspected or actual violation and any corrective action ordered 7 by the department, including the suspension or revocation of any 8 license, permit, or registration." 9 SECTION 3. There is appropriated out of the general 10 revenues of the State of Hawaii the sum of \$ or so much 11 thereof as may be necessary for fiscal year 2017-2018 and the 12 same sum or so much thereof as may be necessary for fiscal year 13 2018-2019 to implement and comply with the reporting 14 requirements for child care facilities as required by this Act. 15 The sums appropriated shall be expended by the department 16 of human services for the purposes of this Act. SECTION 4. Statutory material to be repealed is bracketed 17 18 and stricken. New statutory material is underscored.

SECTION 5. This Act shall take effect on July 1, 2017.
