A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 346-152.7, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+] §346-152.7[+] Safe sleep policy. (a) All child care
- 4 facilities[, which include family child care homes, group child
- 5 care centers, and group child care homes, as those terms are
- 6 defined in section 346-151, and infant and toddler child care
- 7 centers, that are registered or licensed by the department to
- 8 provide care for children less than one year of age shall
- 9 implement and maintain a written safe sleep policy in accordance
- 10 with any rules that may be adopted by the department to
- 11 implement the provisions of this section. The purpose of the
- 12 safe sleep policy shall be to maintain a safe sleep environment
- 13 that prevents the occurrence of sudden infant death syndrome and
- 14 sudden unexpected infant deaths in children less than one year
- 15 of age.
- 16 (b) Each safe sleep policy shall require each child care
- 17 facility to ensure that any child less than one year of age is

- 1 placed on the child's back to sleep, unless written instructions
- 2 are on file at the child care facility from a health care
- 3 practitioner indicating an alternate sleep positioning.
- 4 (c) The provider of the child care facility shall discuss
- 5 the safe sleep policy with the child's parent or legal guardian
- 6 before the child is enrolled in the child care facility. The
- 7 child's parent or legal quardian shall sign a statement
- 8 attesting that the parent or legal guardian received a copy of
- 9 the safe sleep policy and that the policy was discussed with the
- 10 parent or legal guardian before the child's enrollment.
- 11 (d) All employees, household members, and volunteers of a
- 12 child care facility shall complete upon hire, and annually
- 13 thereafter, training in safe sleep practices that is approved by
- 14 the department. Each child care facility shall maintain a
- 15 record of trainings completed.
- (e) Every child care facility shall report to the
- 17 department, within one working day of occurrence, the death of a
- 18 child, employee, or household member, and any illness or injury
- 19 received at the child care facility that results in a child's
- 20 hospitalization.

1	"Child care facility" includes a family child care home,
2	group child care home, and group child care center, as defined
3	in section 346-151, and an infant and toddler child care center.
4	"Sudden infant death syndrome" means the sudden death of ar
5	infant less than one year of age that cannot be explained after
6	a thorough investigation has been conducted, including a
7	complete autopsy, an examination of the death scene, and a
8	review of the clinical history.
9	"Sudden unexpected infant death" means the sudden and
10	unexpected death of an infant less than one year of age in which
11	the manner and cause of death are not immediately obvious prior
12	to investigation. Causes of sudden unexpected infant death
13	include but are not limited to metabolic disorders, hypothermia
14	or hyperthermia, neglect or homicide, poisoning, and accidental
15	suffocation."
16	SECTION 2. Statutory material to be repealed is bracketed
17	and stricken. New statutory material is underscored.
18	SECTION 3. This Act shall take effect on July 1, 2090.

Sudden Infant Death Syndrome; Sudden Unexpected Infant Death; Safe Sleep Policy

Description:

Requires Department of Human Services (DHS) registered or licensed child care facilities to: (1) Place any child less than a year old on the child's back to sleep; (2) Discuss the Safe Sleep Policy with the child's parent or legal guardian before the child is enrolled in the facility; (3) Complete training in safe sleep practices; and (4) Report the death of a child, employee, or household member, and any illness or injury received at the facility to DHS within one working day of occurrence. (SB522 HD1)
