BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 6 Members shall have relevant business and management

13	(23)	Shall arrange or initiate appropriate action for the
14		planning, opening, grading, relocating, or closing of
15		streets, roads, roadways, alleys, easements, or other
16		places; the furnishing of facilities; the acquisition
17		of property or property rights; and the furnishing of
18		property, development rights, or services in
19		connection with any airport or any project,
20		improvement, or facility related thereto;

1	(24)	May grant options or renew any lease entered into by
2		it in connection with any project, on terms and
3		conditions as it deems advisable;
4	(25)	May engage the services of consultants on a
5		contractual basis for rendering professional and
6		technical assistance and advice;
7	(26)	Shall procure insurance against any loss in connection
8		with its property and other assets and operations, in
9		such amounts and from such insurers as it deems
10		desirable, or provide for self-insurance;
11	(27)	May accept and receive gifts or grants in any form
12		from any person, public entity, or source; provided
13		that the grants and gifts shall be used for airport
14		corporation purposes;
15	(28)	May pledge or assign all or any part of the moneys,
16		fees, rents, charges, or other revenues and proceeds
17		derived by the airport corporation from the proceeds
18		of insurance or condemnation awards for the loss of
19		revenues or incurring of costs and expenses because of
20		any action taken by the airport corporation;

1	(29)	Shall fix, impose, prescribe, and collect rates,
2		rentals, fees, or charges for the lease, use, and
3		services of its airport facilities at least sufficient
4		to pay the costs of operation, maintenance, and
5		repair, if any, and the required payments of the
6		principal of, and interest on, all bonds issued or
7		assumed by the airport corporation and reserves
8		therefor;
9	(30)	May engage in economic development programs and
10		contract with the department of business, economic
11		development, and tourism or nonprofit corporations in
12		the furtherance of economic development;
13	(31)	May take all actions necessary under emergencies such
14		as hurricanes, tsunamis, and other natural disasters;
15	(32)	Shall plan, construct, operate, and maintain all
16		airport facilities in the State;
17	(33)	May appropriate and allot airport funds, issue revenue
18		bonds and special facility revenue bonds in its name
19		pursuant to chapter 39, but not in excess of such
20		principal amounts as are necessary for its purposes or
21		specified in covenants with bondholders;

1	(34)	May invest and secure its moneys in accordance with
2		chapters 36 and 38;
3	(35)	May take public and private property for use in
4		furthering any of the purposes of the airport
5		corporation; provided that all proceedings for
6		condemnation shall be conducted in accordance with
7		chapter 101;
8	(36)	May provide compensation, allowance, or other
9		assistance to any person for relocation or
10		displacement caused by the acquisition of land for
11		airport purposes;
12	(37)	May hire or contract law enforcement personnel;
13	(38)	May license all airports and heliports within the
14		State, pursuant to all federal and state rules and
15		regulations, and the procedures of the airport
16		corporation;
17	(39)	May approve all safety, security, and federal
18		certification plans, procedures, and specifications
19		related to the operation, management and development
20		of all airports and heliports within the State; and

1 (40) May do any and all things necessary to carry out its 2 powers and duties pursuant to this chapter." 3 SECTION 3. Section 261-2, Hawaii Revised Statutes, is amended to read as follows: 4 5 "§261-2 Development of aeronautics, general. 6 department of transportation shall have general supervision over 7 aeronautics within the State [+] provided that on July 1, 2018, 8 the general supervision shall be transferred to the Hawaii 9 airport corporation. It shall encourage, foster, and assist in 10 the development of aeronautics in the State and encourage the 11 establishment of airports and air navigation facilities. It 12 shall cooperate with and assist the federal government and other 13 persons in the development of aeronautics and shall seek to 14 coordinate the aeronautical activities of the State with those 15 of the federal government. Municipalities may cooperate with 16 the department in the development of aeronautics and aeronautics 17 facilities in the State." 18 SECTION 4. The Hawaii airport corporation shall be a 19 successor agency, and jurisdiction over aeronautics and

airports, including airport functions under the department of

- 1 transportation's airports division, shall be transferred to the
- 2 Hawaii airport corporation on July 1, 2018.
- 3 To the extent that the Hawaii airport corporation is
- 4 authorized in this Act to exercise powers and duties which are
- 5 also granted to other departments, offices, or boards of the
- 6 State, with respect to airports and aeronautical facilities, the
- 7 Hawaii airport corporation shall exercise such powers and

- 10 SECTION 5. The State shall facilitate the corporation's

- 12 ownership, jurisdiction, assets, liabilities, powers, funds,
- 13 accounts, contracts, employees, and any other rights, benefits,
- 14 or obligations, and authority to control, operate, develop, and
- 15 maintain airports and aeronautical facilities from the
- 16 department of transportation to the corporation prior to July 1,
- **17** 2018.
- 18 SECTION 6. The revisor of statutes shall substitute the
- 19 phrase "Hawaii airport corporation" in chapter 261, Hawaii
- 20 Revised Statutes, wherever the word "department" appears, except

- 1 for the amendments made to section 261-2, Hawaii Revised
- 2 Statutes, in section 3 of this Act.
- 3 SECTION 7. It is the intent of this Act not to jeopardize
- 4 the receipt of any federal aid nor to impair the obligation of
- 5 the State or any agency thereof to the holders of any bond
- 6 issued by the State or by any such agency, and to the extent,
- 7 and only to the extent, necessary to effectuate this intent, the
- 8 governor may modify the strict provisions of this Act, but shall
- 9 promptly report any such modification with reasons therefor to
- 10 the legislature at its next session thereafter for review by the
- 11 legislature.
- 12 SECTION 8. This Act does not affect rights and duties that
- 13 matured, penalties that were incurred, and proceedings that were
- 14 begun before its effective date.
- 15 SECTION 9. If any provision of this Act, or the
- 16 application thereof to any person or circumstance, is held
- 17 invalid, the invalidity shall not affect the other provisions or
- 18 applications of this Act that can be given effect without the
- 19 invalid provision or application, and to this end the provisions
- 20 of this Act are severable.

1 SECTION 10. All rights, powers, functions, and duties of 2 the department of transportation's airports division are 3 transferred to the Hawaii airport corporation on July 1, 2018. 4 The Hawaii airport corporation shall be a successor employer to 5 the State, and shall recognize all bargaining units and 6 collective bargaining agreements existing at the time of 7 transfer to the corporation. The employees of the corporation 8 shall be considered employees of the State as provided in this 9 section. The corporation shall not be required to comply with 10 the policies of the department of human resource development 11 with regard to approval for the creation of new positions, the 12 number of such positions, the decision to fill such positions, 13 or the time for filling such positions. 14 All employees who occupy civil service positions and whose 15 functions are transferred to the Hawaii airport corporation by this Act shall retain their civil service status, whether 16 17 permanent or temporary. Employees shall be transferred without 18 loss of salary, seniority (except as prescribed by applicable 19 collective bargaining agreements), retention points, prior 20 service credit, any vacation and sick leave credits previously 21 earned, and other rights, benefits, and privileges, in

- 1 accordance with state personnel laws and this Act; provided that
- 2 the employees possess the minimum qualifications and public
- 3 employment requirements for the class or position to which
- 4 transferred or appointed, as applicable.
- 5 Any employee who, prior to this Act, is exempt from civil
- 6 service and is transferred as a consequence of this Act may
- 7 retain the employee's exempt status, but shall not be appointed
- 8 to a civil service position as a consequence of this Act. An
- 9 exempt employee who is transferred by this Act shall not suffer
- 10 any loss of prior service credit, vacation or sick leave credits
- 11 previously earned, or other employee benefits or privileges as a
- 12 consequence of this Act; provided that the employees possess
- 13 legal and public employment requirements for the position to
- 14 which transferred or appointed, as applicable. The chief
- 15 executive officer of the Hawaii airport corporation may
- 16 prescribe the duties and qualifications of these employees and
- 17 fix their salaries without regard to chapter 76, Hawaii Revised
- 18 Statutes.
- 19 No employee covered by a collective bargaining unit as an
- 20 employee of the department of transportation shall be laid off
- 21 as a result of the creation of the Hawaii airport corporation.



- 1 The officers and all other employees of the Hawaii airport
- 2 corporation shall be State employees for the purposes of
- 3 benefits and retirement. The corporation shall reimburse the
- 4 appropriate state agencies for all costs incurred by such
- 5 designation.
- 6 In addition to positions transferred to the corporation,
- 7 the Hawaii airport corporation may create one or more new
- 8 classifications of employees as determined by the board of
- 9 directors of the corporation. Such classifications shall not be
- 10 deemed comparable to other civil service classifications, and
- 11 may be exempt from classified service. On and after July 1,
- 12 2018, the corporation may hire employees into new unclassified
- 13 positions without regard to any collective bargaining agreement
- 14 then in effect and may set the initial terms and conditions of
- 15 employment for all employees in new unclassified positions.
- 16 SECTION 11. On July 1, 2018, all appropriations, records,
- 17 equipment, machines, files, supplies, contracts, books, papers,
- 18 documents, maps, and other personal property heretofore made,
- 19 used, acquired, or held by the department of transportation
- 20 relating to the functions transferred to the Hawaii airport

- 1 corporation shall be transferred with the functions to which
- 2 they relate.
- 3 SECTION 12. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 13. This Act shall take effect on July 1, 2017.
