A BILL FOR AN ACT

RELATING TO THE STATEWIDE TRAFFIC CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 291C-41, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "[{]\$291C-41[}] Drive on right side of roadway; 4 exceptions. (a) Upon all roadways of sufficient width a 5 vehicle shall be driven upon the right half of the roadway, except as follows: 6 7 (1) When overtaking and passing another vehicle proceeding 8 in the same direction under the rules governing such 9 movement; 10 (2) When an obstruction exists making it necessary to 11 drive to the left of the center of the highway; 12 provided any person so doing shall yield the right-of-13 way to all vehicles traveling in the proper direction 14 upon the unobstructed portion of the highway within 15 such distance as to constitute an immediate hazard;
 - (3) Upon a roadway divided into three marked lanes for traffic under the rules applicable thereon; or

- (4) Upon a roadway designated and signposted one-way
 traffic.
- 3 (b) Upon all roadways any vehicle proceeding at less than
- 4 the normal speed of traffic at the time and place and under the
- 5 conditions then existing shall be driven in the right-hand lane
- 6 then available for traffic, or as close as practicable to the
- 7 right-hand curb or edge of the roadway, except when overtaking
- 8 and passing another vehicle proceeding in the same direction or
- 9 when preparing for a left turn at an intersection or into a
- 10 private road or driveway.
- 11 (c) Upon any roadway having four or more lanes for moving
- 12 traffic and providing for two-way movement of traffic, no
- 13 vehicle shall be driven to the left of the center line of the
- 14 roadway, except when authorized by official traffic-control
- 15 devices designating certain lanes to the left side of the center
- 16 of the roadway for use by traffic not otherwise permitted to use
- 17 such lanes, or except as permitted under subsection (a)(2).
- 18 This subsection shall not be construed to prohibit the crossing
- 19 of the center line in making a left turn into or from an alley,
- 20 private road, or driveway.

18		lane other than the right lane; or
19	(5)	Situations where the right half of a roadway is closed
20		to traffic while under construction or repair.

12	"Truck-trailer combination" shall have the same meaning as

14	SECTION 2. Section 291C-102, Hawaii Revised Statutes, is		
15	amended by amending subsection (a) to read as follows:		
16	"(a) A person violates this section if the person drives:		
17	(1) A motor vehicle at a speed greater than the maximum		
18	speed limit other than provided in section 291C-105[-

20	(2) A motor vehicle at a speed] or less than the minimum		
21	speed limit, where the maximum or minimum speed limit		

1		is established by county ordinance or by official
2		signs placed by the director of transportation on
3		highways under the director's jurisdiction[-]; or
4	(2)	A truck, as defined in section 286-2, having a gross
5		vehicle weight rating in excess of ten thousand
6		pounds, at a speed greater than fifty-five miles per
7		hour."

Traffic Safety; Trucks; Speed Limit

Description:

Prohibits certain large vehicles of more than 10,000 pounds from being driven on the far left lane of any roadway having three or more lanes, with certain exceptions. Establishes a fifty-five mile per hour speed limit for trucks having a gross vehicle weight rating in excess of 10,000 pounds.
