### A BILL FOR AN ACT

RELATING TO ELECTIONS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
- 2 by adding a new section to part XIII, subpart E, to be
- 3 appropriately designated and to read as follows:
- 4 "§11- Contributions during legislative session
- 5 prohibited; fundraising. (a) No entity, firm, association,
- 6 corporation, nonprofit corporation, chapter S corporation,
- 7 limited liability company, general partnership, limited
- 8 partnership, or lobbyist shall make a monetary or in-kind
- 9 contribution to a candidate who is a member of the legislature
- 10 or make a loan to a candidate who is a member of the legislature
- 11 or to that candidate's candidate committee or noncandidate
- 12 committee during any regular legislative session, during the
- 13 five calendar days following adjournment sine die, and during
- 14 any special session.
- 15 (b) No candidate who is a member of the legislature shall
- 16 knowingly solicit or accept a contribution from a lobbyist or
- 17 person by whom the lobbyist is retained or employed or on whose

- 1 behalf the lobbyist appears or works during any regular
- 2 legislative session, during the five calendar days after
- 3 adjournment sine die, and during any special session.
- 4 (c) No fundraiser for any candidate who is a member of the
- 5 legislature shall be held during any regular legislative
- 6 session, during the five calendar days after adjournment sine
- 7 die, and during any special session.
- 8 (d) For the purposes of this section, "lobbyist" shall
- 9 have the same meaning as in section 97-1."
- 10 SECTION 2. New statutory material is underscored.
- 11 SECTION 3. This Act shall take effect on January 1, 2018.

#### Report Title:

Campaign Contributions; Legislative Sessions; Fundraisers

### Description:

Prohibits campaign contributions from certain entities to members of the legislature during the legislative session, for five days following adjournment sine die, and during a special session. Prohibits a member of the legislature from knowingly soliciting or accepting a contribution from a lobbyist or a lobbyist's principal during a legislative session, for five days following adjournment sine die, and during a special session. Prohibits fundraisers for any member of the legislature to be held during any regular legislative session, for five calendar days after adjournment sine die, and during a special session. Takes effect on 1/1/2018.
