PURPOSE: The purpose of this bill is to establish the

Agribusiness Modernization Program to

provide financial support for agricultural-

related improvements to existing and

emerging farms and agribusiness operations.

MEANS:

Add a new section to chapter 163D, Hawaii

Revised Statutes.

JUSTIFICATION:

The Agribusiness Development Corporation (ADC) is an attached agency to the Hawaii Department of Agriculture.

ADC is the State agency tasked with transitioning former plantation land and water systems for diversified agriculture.

The proposed amendment would allow the corporation to make administrative grants and provide financial support to existing and emerging farms and agribusiness operations.

ADC ability to issue grants may assist in agricultural-related improvements such as modernizing existing and emerging agricultural operations, equipment modernization and/or replacement, expanding or scaling-up farm/agribusiness operation, and developing new markets and products.

Impacts on the public: Provide ADC with the ability to make investments to diversify Hawaii's agricultural industry, attract and retain agricultural-related businesses, and
