A BILL FOR AN ACT

RELATING TO PARKING FOR DISABLED PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the statewide
- 2 parking program for persons with disabilities, as established
- 3 under part III of chapter 291, Hawaii Revised Statutes, pursuant
- 4 to the federal Uniform System for Handicapped Parking Act,
- 5 Public Law 100-641, and administered by the disability and
- 6 communication access board, provides individuals with mobility
- 7 disabilities the ability to travel and park in accessible
- 8 parking stalls.
- 9 The legislature finds that the exemption from payment of
- 10 parking meter fees for the first two-and-a-half hours or the
- 11 maximum time the meter allows, whichever is longer, was a
- 12 privilege not intended as a benefit for persons with mobility
- 13 impairments who qualified for a disability parking permit. The
- 14 exemption was established as a broad exemption for permittees,
- 15 because the legislature recognized that some permittees who were
- 16 licensed drivers could not reach or operate a parking meter
- 17 because of a disability.

The legislature finds that the rationale for exempting such individuals is still justified; however, the exemption should 2 3 not extend to permittees who are able to reach and operate 4 parking meters or to permittees who are transported in vehicles 5 driven by another person because the driver is able to reach and 6 operate a parking meter. 7 The legislature further finds that it is necessary to distinguish permittees who are licensed drivers and not able to 8 9 operate parking meters because of a disability from other 10 permittees. Therefore, the disability and communication access 11 board shall develop a disability parking permit that is different in appearance from those currently issued or a decal 12 13 that is affixed onto current disability parking permits that 14 will indicate to law enforcement that a vehicle displaying such a disability parking permit or decal is authorized to park in 15 16 metered parking spaces without payment of parking meter fees for the first two-and-a-half hours or the maximum time the meter 17 allows, whichever is longer. 18 The purpose of this Act is to limit the privilege of 19 20 parking a vehicle in a metered parking space without payment of 21 parking meter fees for the first two-and-a-half hours or the 22 maximum time the meter allows, whichever is longer, only to

- 1 permittees who are licensed drivers and not able to operate
- 2 parking meters because of a disability.
- 3 SECTION 2. Chapter 291, Hawaii Revised Statutes, is
- 4 amended by adding to part III a new section to be appropriately
- 5 designated and to read as follows:
- 6 "<u>\$291-</u> Issuance of distinguishing parking permit or
- 7 decal. The issuing agency shall issue one distinguishing
- 8 parking permit or decal to each applicant who presents a
- 9 certificate of disability that verifies that the applicant is
- 10 licensed to drive a motor vehicle and cannot reach or operate
- 11 parking meters because of a physical disability. The
- 12 distinguishing parking permit or decal shall have the same
- 13 expiration as the removable windshield placard, temporary
- 14 removable windshield placard, or special license plates issued
- 15 to the applicant."
- SECTION 3. Section 291-51, Hawaii Revised Statutes, is
- 17 amended by adding a new definition to be appropriately inserted
- 18 and to read as follows:
- ""Distinguishing parking permit or decal" means a two-
- 20 sided, hanger-style placard or a decal affixed to a current
- 21 disability parking permit or a document displayed on a dashboard
- 22 issued under this part to a person with a disability who

- 1 presents a certificate of disability that verifies that the
- 2 applicant is licensed to drive a motor vehicle and cannot reach
- 3 or operate a parking meter because of a physical disability."
- 4 SECTION 4. Section 291-55, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "\$291-55 Metered parking privileges. Any vehicle
- 7 displaying [special license plates, a removable windshield
- 8 placard, or a temporary removable windshield placard] a
- 9 distinguishing parking permit or decal issued under this part
- 10 shall be permitted to park, without payment of metered parking
- 11 fees, in any metered parking space for a maximum of two-and-a-
- 12 half hours or the maximum amount of time the meter allows,
- 13 whichever is longer. All parking fees not specifically exempted
- 14 under this part shall remain in effect. The vehicle shall
- 15 prominently display the distinguishing parking permit or decal
- 16 when parked in a metered parking space."
- 17 SECTION 5. Section 291-56, Hawaii Revised Statutes, is
- 18 amended to read as follows:
- 19 "§291-56 Rules. The disability and communication access
- 20 board shall adopt rules under chapter 91 to carry out the
- 21 purposes of this part, including rules for:

Report Title:

Disabled Persons Parking; Paying Parking Meter Fees

Description:

Limits the exemption from payment of parking meter fees to vehicles that display a distinguishing parking permit or decal issued to an applicant who presents a certificate of disability that verifies that the applicant is licensed to drive a motor vehicle and cannot reach or operate a parking meter because of a physical disability.

TITLE:

A BILL FOR AN ACT RELATING TO PARKING FOR

DISABLED PERSONS.

PURPOSE:

To limit the exemption from payment of parking meter fees to an applicant who presents a certificate of disability verifying that the applicant is licensed

verifying that the applicant is licensed to drive a motor vehicle and cannot reach or operate parking meters because of physical

disability or architectural barriers.

MEANS:

Add new section to part III of chapter 291 and amend sections 291-51, 291-55, and 291-

56, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

The original intent of this section of the law was to allow the privilege of not paying parking meter fees to a person with a physical disability that resulted in the lack of ability to feed the parking meter. The way the law is currently written, anyone who has a parking permit for a person with a disability is exempt from paying the meter, whether or not the person can physically feed the meter. While the rationale for exempting the payment of a parking meter is still justified, the exemption should be restricted to permittees who own and drive their own vehicle, and not for someone who drives and is able to feed the meter, or who is transporting an individual with a disability who can also feed the meter.

Impact on the public: Anyone with disability who qualifies for a parking permit for disabled persons, and is able to feed the meter will be required to pay the meter for the amount of time the parking space is used, similar to the general public. Anyone who has a physical

disability limiting the ability to pay the meter is still exempt from feeding the meter and will be issued a distinguishing parking permit or decal that will indicate the person is exempt from feeding the meter.

Impact on the department and other agencies:
The bill requires the Disability and
Communication Access Board to amend existing
administrative rules to establish a method
for law enforcement officers to recognize
parking permits for persons with
disabilities that exempt the driver from
feeding the meter.

State and county agencies that maintain parking meters should see an increase in revenue generated from metered parking spaces.
