SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF HEALTH TO HIRE A STATE VETERINARY
MEDICAL OFFICER TO PREVENT THE SPREAD OF RAT LUNGWORM
DISEASE AND OTHER ZONOTIC DISEASES IN THE STATE'S HUMAN
POPULATION AND TO SUPPORT STATEWIDE EFFORTS IN PROTECTING
AND IMPROVING HUMAN HEALTH.

1 WHEREAS, zoonotic diseases are caused by infection from
2 viruses, bacteria, parasites, or fungi and can be transmitted
3 directly or indirectly to humans by consumption of contaminated
4 foodstuffs or contact with infected animals; and

5
6 WHEREAS, zoonotic diseases can cause illness of varying
7 severity or even death in people; and

8
9 WHEREAS, the Centers for Disease Control and Prevention
10 reports that zoonotic diseases are very common and every year
11 tens of thousands of Americans will get sick from them; and

12
13 WHEREAS, leptospirosis, E. coli infection, methicillin-
14 resistant staphylococcus aureus infection, ringworm,
15 toxoplasmosis, salmonella infection, tuberculosis, H1N1 and H3N2
16 influenza virus, also known as bird flu or swine flu,
17 brucellosis caused by Brucella suis, and angiostrongyliasis
18 cantonensis, more commonly known as rat lungworm disease, are
19 examples of zoonotic diseases; and

20
21 WHEREAS, zoonotic diseases are very well understood and
22 studied by veterinarians; and

23
24 WHEREAS, the Legislature finds that in the past, the
25 Department of Health had a Public Health Veterinarian position
26 that was filled by a doctor of veterinary medicine; and



1 WHEREAS, David Sasaki, doctor of veterinary medicine and a
2 world expert on leptospirosis, filled that position, and also
3 oversaw the production of public health publications that were
4 distributed to Hawaii physicians and veterinarians; and
5

6 WHEREAS, those publications were well received and helped
7 educate physicians about disease reporting requirements, the
8 prevalence of a number of diseases in the State, and the
9 appropriate treatment for the diseases; and
10

11 WHEREAS, while the publications provided vital information
12 on specific topics such as resistance to antibiotics of common
13 venereal diseases such as gonorrhoea, the publications also
14 provided a deeper understanding of the risk of animal diseases
15 to humans; and
16

17 WHEREAS, most health departments across the nation have a
18 position filled by a doctor of veterinary medicine that is
19 usually designated as a public health veterinarian; and
20

21 WHEREAS, establishing a State Veterinary Medical Officer
22 position within the Department of Health may help to prevent the
23 spread of rat lungworm disease and other zoonotic diseases in
24 the State's human population and support statewide efforts to
25 protect and improve human health; and
26

27 WHEREAS, a State Veterinary Medical Officer could also
28 revive public health publications and disseminate the
29 publications in electronic form, as well as couple the
30 publications with continuing medical education for physicians,
31 nurses, and veterinarians to help ensure that the State's health
32 care workforce is continually updated on the latest information
33 on zoonotic diseases; and
34

35 WHEREAS, a State Veterinary Medical Officer may also help
36 address the current outbreak of rat lungworm disease in humans,
37 dogs, cats, and horses in the State; and

39 WHEREAS, global warming contributes to the increase of the
40 number and types of viruses, bacteria, parasites, and fungi that
41 are spread between animals and humans, which makes early



1 detection and study of these vectors and the illnesses they
2 cause imperative to protect public health; now, therefore,
3

4 BE IT RESOLVED by the Senate of the Twenty-ninth
5 Legislature of the State of Hawaii, Regular Session of 2018, the
6 House of Representatives concurring, that the Department of
7 Health is requested to hire a State Veterinary Medical Officer
8 to help prevent the spread of rat lungworm disease and other
9 zoonotic diseases in the State's human population and support
10 statewide efforts to protect and improve human health; and
11

12 BE IT FURTHER RESOLVED that certified copies of this
13 Concurrent Resolution be transmitted to the Director of Health.
