The Professional and Vocational Licensing Division of the Department of Commerce and Consumer Affairs and Hawaii Medical Service Association provided comments.

Your Committee has amended this measure by:

 Specifying the national certifying agencies by which individuals exempt from licensure must be credentialed or certified; and
