Your Committee on Finance, to which was referred H.B. No. 2275, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Make owners who charge a fee for the use of a private street, highway, or thoroughfare located within the Kakaako Community Development District and used continuously by the general public for at least six months responsible for the costs of conforming and maintaining the private streets, highways, or thoroughfares to meet county construction and maintenance standards; and
- (2) Exempt private streets, highways, or thoroughfares used solely by the owner or employees of the owner from the requirements established by this measure.

The Department of Transportation, Hawaii Community Development Authority, Bank of Hawaii, Oahu County Committee on Legislative Priorities of the Democratic Party of Hawaii, Hawaii Gas, and a few individuals testified in support of this measure. As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 2275, H.D. 2, and recommends that it pass Third Reading.
