Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2362, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO ADMINISTRATIVE HEARING OFFICERS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to exempt Department of Human Services' Administrative Appeals Hearing Officer positions from civil service requirements.

Your Committee on Conference has amended this measure by:

- (1) Inserting an effective date of July 1, 2018; and
- (2) Making technical, nonsubstantive amendments for clarity.


