"HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENTS OF AGRICULTURE AND HEALTH TO EVALUATE CALIFORNIA'S CURRENT AND PENDING REGULATIONS ON CHLORPYRIFOS AND MAKE RECOMMENDATIONS FOR IMPLEMENTATION OF SIMILAR REGULATIONS IN HAWAII,"

The purpose of this measure is to request the Departments of Agriculture and Health to jointly evaluate California's current and pending regulations on chlorpyrifos and develop recommendations for similar regulations applicable to Hawaii, evaluate any negative impact on Hawaii if the Environmental Protection Agency regulations on chlorpyrifos are not implemented, and report to the Legislature prior to the 2019 Regular Session.

The Oahu County Committee on Legislative Priorities of the Democratic Party of Hawaii, Animal Rights Hawaii, Life of the Land, and an individual supported this measure. The Hawaii Cattlemen's Council, Inc. opposed this measure. The Department of Agriculture, Department of Health, and Hawaii Farm Bureau provided comments.
