REGULATION OF PERSONAL VEHICLE RENTALS AND TO CONSIDER

The purpose of this measure is to request the Department of
Transportation to convene a working group to evaluate the
regulation of personal vehicle rentals and to consider standards
of practice for this emerging and currently unregulated industry
to ensure the safety of the public.

The Department of Transportation testified in opposition to
this measure. Turo Inc. and Enterprise Holdings provided comments
on this measure.


Your Committee has amended this measure by requesting that
the working group research and review safety and maintenance
standards, liability and insurance limits, airport and public
access, and pricing, fees, and taxes as they pertain to personal
vehicle rentals.
