Your Committee on Transportation, to which was referred H.R. No. 81 entitled:

"HOUSE RESOLUTION URGING THE DEPARTMENT OF TRANSPORTATION TO ENGAGE IN PUBLIC EDUCATION AND OUTREACH TO REDUCE LITTERING, PROMOTE AND ENCOURAGE PARTICIPATION IN THE ADOPT-A-HIGHWAY PROGRAM TO KEEP ROADS LITTER-FREE, AND WORK WITH THE COUNTIES TO EXPAND THE ADOPT-A-HIGHWAY PROGRAM TO INCLUDE COUNTY ROADS,"
