Your Committee on Finance, to which was referred S.B. No. 1068, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PROCUREMENT,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Prohibit the disqualification or rejection of a bid that includes a listed subcontractor whose license is not valid at the time of the bid due to a lapse in continuous insurance and bond coverage if the subcontractor meets certain conditions; and
- (2) Require procurement officers to report any unlicensed activity to the Contractors License Board if a bid is disqualified or rejected because the subcontractor failed to meet certain licensing requirements.

The General Contractors Association of Hawaii supported this measure. The State Procurement Office and Iron Workers Stabilization Fund opposed this measure. The Regulated Industries Complaints Office of the Department of Commerce and Consumer Affairs, Department of Transportation, Subcontractors Association

of Hawaii, and Plumbing and Mechanical Contractors Association of Hawaii provided comments.
